### 1 Accounting policies

#### Company information

Airow Defence Deployment Limited is a private company limited by shares incorporated in England and Wales. The registered office is Hadrian House, Front Street, Chester le Street, Co. Durham, United Kingdom, DH3 3DB.

#### 1.1 Accounting convention

These financial statements have been prepared in accordance with FRS 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland" ("FRS 102") and the requirements of the Companies Act 2006 as applicable to companies subject to the small companies regime. The disclosure requirements of section 1A of FRS 102 have been applied other than where additional disclosure is required to show a true and fair view.
