

THIS DEED is dated \ March 2015 and is made

BETWEEN.

- (1) HOTEL COLLECTION HOTEL NO. 6 LIMITED (Registered number 09174142),
- (2) HOTEL COLLECTION HOTEL NO. 18 LIMITED (Registered number 09174161) (together with Hotel Collection Hotel No 6 Limited, the Chargors, and each a Chargor), and
- (2) LSREF III WIGHT LIMITED (the Lender)

BACKGROUND

- (A) Under a Security Agreement dated 11 September 2014 (the **Original Security Agreement**) between the Chargors and the Lender, the Chargors charged by way of first legal mortgage, first mortgage, first fixed charge and assignment by way of security certain of its assets as security for, amongst other things, the present and future obligations and liabilities of each Obligor under the Finance Documents (as amended or supplemented)
- (B) In accordance with the Secured Loan Agreement, each Chargor has acquired a Third Party Consent Property and, accordingly, the Chargors have agreed to enter into this Deed in connection with the Secured Loan Agreement
- (C) This Deed is supplemental to the Original Security Agreement.
- (D) It is intended that this document takes effect as a deed notwithstanding the fact that a party may only execute this document under hand.

IT IS AGREED as follows

1. INTERPRETATION

- (a) Capitalised terms defined in the Original Security Agreement have, unless expressly defined in this Deed, the same meaning in this Deed
- (b) The provisions of clause 1.2 (Construction) of the Secured Loan Agreement apply to this Deed as though they were set out in full in this Deed except that references to the Secured Loan Agreement will be construed as references to this Deed

(c)

- (1) A Finance Document or other agreement or instrument includes (without prejudice to any prohibition on amendments) any amendment to that Finance Document or other agreement or instrument, including any change in the purpose of, any extension of or any increase in the amount of a facility or any additional facility,
- (11) the term this Security means any security created by this Deed, and
- (iii) a reference to any **asset** includes present and future properties, revenues and rights of every description
- (d) Any covenant of the Chargors under this Deed (other than a payment obligation) remains in force during the Security Period

- (e) The terms of the other Finance Documents and of any side letters between any Parties in relation to any Finance Document are incorporated in this Deed to the extent required to ensure that any purported disposition of any freehold or leasehold property contained in this Deed is a valid disposition in accordance with section 2(1) of the Law of Property (Miscellaneous Provisions) Act 1989
- (f) If the Lender considers that an amount paid to it under a Finance Document is capable of being avoided or otherwise set aside on the liquidation or administration of the payer or otherwise, then that amount will not be considered to have been irrevocably paid for the purposes of this Deed
- (g) Unless the context otherwise requires, a reference to a Security Asset includes the proceeds of sale of that Security Asset

2. CREATION OF SECURITY

2.1 General

All the security created under this Deed

- (a) is created in favour of the Lender,
- (b) is created over present and future assets of each Chargor,
- (c) is security for the payment and satisfaction of all the Secured Liabilities, and
- (d) is made with full title guarantee in accordance with the Law of Property (Miscellaneous Provisions) Act 1994

2.2 Land

- (a) Each Chargor charges by way of a first legal mortgage the property specified in the Schedule under its name under the heading **Real Property**
- (b) A reference in this Clause to a mortgage or charge of any freehold or leasehold property includes
- (c) all buildings, fixtures, fittings and fixed plant and machinery on that property, and
- (d) the benefit of any covenants for title given or entered into by any predecessor in title of the relevant Chargor in respect of the relevant property or any moneys paid or payable in respect of those covenants

2.3 Confirmation

Each Chargor confirms that, as security for the payment of the Secured Liabilities

- (a) It has charged in favour of the Lender by way of first fixed charge the assets relating to the property specified in the Schedule and referred to in clauses 2.3 (Investments) to 2.6 (Miscellaneous) inclusive of the Original Security Agreement, and
- (b) It has assigned to the Lender by way of security the assets relating to the property specified in the Schedule and referred to in clause 2.5 (Intercompany Loan Agreement) of the Original Security Agreement

3. INCORPORATION

The provisions of clause 3 (Representations – General) to 18 (Release) (inclusive) (other than clause 5.5 (H M Land Registry)) of the Original Security Agreement are deemed to be incorporated into this Deed with all necessary modifications as if they were set out in full in this Deed

4. H.M. LAND REGISTRY

Each Chargor consents to a restriction in the following terms being entered into on the Register of Title relating to any Mortgaged Property registered at H M. Land Registry

"No disposition of the registered estate by the proprietor of the registered estate is to be registered without a written consent signed by the proprietor for the time being of the charge dated [] in favour of [] referred to in the charges register or their conveyancer (Standard Form P)"

5. CONTINUATION

- (a) Except insofar as supplemented by this Deed, the Original Security Agreement will remain in full force and effect
- (b) References in the Original Security Agreement to **this Deed** and expressions of similar import are deemed to be references to the Original Security Agreement as amended by this Deed and to this Deed
- (c) This Deed is designated a Finance Document

6. GOVERNING LAW

This Deed and any non-contractual obligations arising out of or in connection with it are governed by English law
