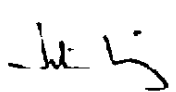

ORDER

UPON the Application of the Applicant dated 14 April 2020 ("the Application")

AND UPON the Court directing that there be a remote hearing in accordance with the Remote Hearings Protocol and paragraph 6.1 of the Temporary Insolvency Practice Direction supporting the Insolvency Practice Direction as a result of the current pandemic

AND UPON READING the evidence

AND UPON THE COURT NOTING the representations of the Insolvency Service contained in an email from Laura Holmes at the Insolvency Service of 10:52 on 16 April 2020 and rehearsed to the Court by the Applicant's Counsel

AND UPON HEARING via video-conference Miss Carly Sandbach of Counsel for the Applicant

IT IS ORDERED that:

1. To the extent necessary, each of the cases listed in the Schedule (attached hereto) currently proceeding in (i) the Business and Property Courts at Leeds, and (ii) the Business and Property Courts of England and Wales, be transferred to the Business and Property Courts at Manchester for the purpose of the determination and disposal of this Application pursuant to CPR 30.2(4)(a) and/or paragraph 3.1 of PD57AA.
2. Immediately upon this order being made, the cases referred to in paragraph 1 above, be transferred back to the Courts from which they were transferred pursuant to CPR 30.2(4)(a) and/or paragraph 3.1 of PD57AA.
3. Julien Robert Irving ("the Applicant"), be removed from his office as one of the joint administrators in respect of the companies in administration which are set out in Schedules A1, A2, A3 and A4 attached hereto, pursuant to rr. 12.36(2), 12.37(1)(c), 12.37(3)(b) Insolvency Rules 2016 ("IR16") and s.19 and paragraph 88 of Sch.B1 Insolvency Act 1986 ("IA86").
4. The First Respondent, Katy McAndrew, shall be appointed as one of the joint administrators of the companies in administration listed in Schedule A1 in place of the Applicant pursuant to rr. 12.36(2), 12.37(1)(d) and 12.37(3)(b) IR16, and s.13 and paragraphs 63, 91 and 95 of Sch.B1 IA86.
5. The Second Respondent, Mike Dillon, shall be appointed as one of the joint administrators of the companies in administration listed in Schedule A2 in place of the Applicant pursuant to rr. 12.36(2), 12.37(1)(d) and 12.37(3)(b) IR16, and s.13 and paragraphs 63, 91 and 95 of Sch.B1 IA86.
6. The Third Respondent, Andrew Poxon, shall be appointed as one of the joint administrators of the companies in administration listed in Schedule A3 in place of the Applicant pursuant to rr. 12.36(2), 12.37(1)(d) and 12.37(3)(b) IR16, and s.13 and paragraphs 63, 91 and 95 of Sch.B1 IA86.
7. The Fourth Respondent, Sean Williams, shall be appointed as one of the joint administrators of the companies in administration listed in Schedule A4 in place of the Applicant pursuant to rr. 12.36(2), 12.37(1)(d) and 12.37(3)(b) IR16, and s.13 and paragraphs 63, 91 and 95 of Sch.B1 IA86.
8. Pursuant to r.12.37(1)(e) IR16, the proposals approved by creditors in each of the administrations listed in Schedules A1, A2, A3 and A4 attached hereto do stand amended so that all references to the Applicant are replaced by references to the incoming replacement officeholder provided for in paragraphs 4, 5, 6 and 7 above.

9. The Applicant, be removed from his office as one of the joint supervisors of the company and/or partnership voluntary arrangements listed in Schedule B1, B2, B3 and B4 pursuant to rr. 12.37(1)(c) and 12.37(2)(a), s. 7(5) and para 39(6) Sch.A1 IA86, and Art. 4(1) of the Insolvent Partnerships Order 1994 and Part 1 of Schedule 1 thereto.
10. The First Respondent, Katy McAndrew, shall be appointed as one of the joint supervisors of the company and/or partnership voluntary arrangements listed in Schedule B1 in place of the Applicant pursuant to rr. 12.37(1)(d) and 12.37(3)(a) IR16 and s. 7(5) and para 39(6) Sch.A1 IA86, and Art. 4(1) of the Insolvent Partnerships Order 1994 and Part 1 of Schedule 1 thereto.
11. The Fifth Respondent, Martin Maloney, shall be appointed as one of the joint supervisors of the company and/or partnership voluntary arrangements listed in Schedule B2 in place of the Applicant pursuant to rr. 12.37(1)(d) and 12.37(3)(a) IR16 and s. 7(5) and para 39(6) Sch.A1 IA86, and Art. 4(1) of the Insolvent Partnerships Order 1994 and Part 1 of Schedule 1 thereto.
12. The Third Respondent, Andrew Poxon, shall be appointed as one of the joint supervisors of the company and/or partnership voluntary arrangements listed in Schedule B3 in place of the Applicant pursuant to rr. 12.37(1)(d) and 12.37(3)(a) IR16 and s. 7(5) and para 39(6) Sch.A1 IA86, and Art. 4(1) of the Insolvent Partnerships Order 1994 and Part 1 of Schedule 1 thereto.
13. The Second Respondent, Mike Dillon, shall be appointed as one of the joint supervisors of the company and/or partnership voluntary arrangements listed in Schedule B4 in place of the Applicant pursuant to rr. 12.37(1)(d) and 12.37(3)(a) IR16 and s. 7(5) and para 39(6) Sch.A1 IA86, and Art. 4(1) of the Insolvent Partnerships Order 1994 and Part 1 of Schedule 1 thereto.
14. The Applicant, be removed from his office as one of the joint liquidators of the companies in compulsory liquidation listed in Schedule C1 and C2 pursuant to rr. 12.36(2), 12.37(1)(c) and 12.37(2)(d) IR16 and s. 172(2) IA86.
15. The First Respondent, Katy McAndrew, shall be appointed as one of the joint liquidators of the companies in compulsory liquidation listed in Schedule C1 in place of the Applicant pursuant to rr. 12.36(2), 12.37(1)(d) and 12.27(3)(d) IR16 and s. 168(3) and (5) IA86.
16. The Sixth Respondent, Steve Markey, shall be appointed as one of the joint liquidators of the companies in compulsory liquidation listed in Schedule C2 in place of the Applicant pursuant to rr. 12.36(2), 12.37(1)(d) and 12.27(3)(d) IR16 and s. 168(3) and (5) IA86.
17. The Applicant be removed from his office as one of the joint liquidators of the companies in creditors' voluntary liquidation listed in Schedules D1, D2, D3, D4, D5 and D6 pursuant to rr. 12.37(1)(c) and 12.37(2)(c) IR16 and section 108 IA86.
18. The Sixth Respondent, Steve Markey, shall be appointed as one of the joint liquidators of the companies in creditors' voluntary liquidation listed in Schedule D1 in place of the Applicant pursuant to rr.12.37(1)(d) and 12.37(3)(c) IR16 and section 108 IA86.

19. The First Respondent, Katy McAndrew, shall be appointed as one of the joint liquidators of the companies in creditors' voluntary liquidation listed in Schedule D2 in place of the Applicant pursuant to rr.12.37(1)(d) and 12.37(3)(c) IR16 and section 108 IA86.
20. The Third Respondent, Andrew Poxon, shall be appointed as one of the joint liquidators of the companies in creditors' voluntary liquidation listed in Schedule D3 in place of the Applicant pursuant to rr.12.37(1)(d) and 12.37(3)(c) IR16 and section 108 IA86.
21. The Second Respondent, Mike Dillon, shall be appointed as one of the joint liquidators of the companies in creditors' voluntary liquidation listed in Schedule D4 in place of the Applicant pursuant to rr.12.37(1)(d) and 12.37(3)(c) IR16 and section 108 IA86.
22. The Seventh Respondent, Megan Singleton, shall be appointed as one of the joint liquidators of the companies in creditors' voluntary liquidation listed in Schedule D5 in place of the Applicant pursuant to rr.12.37(1)(d) and 12.37(3)(c) IR16 and section 108 IA86.
23. The Eighth Respondent, Michelle Elliott, shall be appointed as one of the joint liquidators of the companies in creditors' voluntary liquidation listed in Schedule D6 in place of the Applicant pursuant to rr.12.37(1)(d) and 12.37(3)(c) IR16 and section 108 IA86.
24. The creditors and members in each of the block transfer cases listed in the Schedule be notified of this order by the Applicant placing notice of it in the London Gazette within 28 days of the date of this order.
25. Any creditor in respect of any of the companies listed in the Schedule who has an objection to this order shall have 28 days from the date of the advertisement to apply to court to set aside or vary the terms of this order. Such application shall not affect the transfer of the block transfer cases the Schedule until further or other order by the court.
26. The replacement officeholders do file any appropriate notices in respect of the removal of the Applicant and the appointment of the replacement officeholders with the Secretary of State for Business, Energy & Industrial Strategy (Insolvency Service) and the Registrar of Companies as may be required.
27. Nothing in this order shall release the Applicant from any obligation to give and file notices in respect of his removal under this order in respect of the block transfer cases listed in the Schedule.
28. The Applicant shall have his release and be discharged from liability as office-holder in respect of all the Appointments in the Schedule hereto, 28 days after the publication of a Notice in the Gazette as provided for by paragraph 24 of this Order.
29. The costs of this application shall be paid as an expense and shall be apportioned equally between each of the block transfer cases, so that the estate of each such case shall bear an equal proportion of the costs.
