

BETWEEN:

- STEPEHN RATZKER of 78-90 Cheshire Street, London, E2 ("the Seller") of the one part and
- 2 **CYGNET STREET DEVELOPMENTS LIMITED** (Company No 09200085) whose registered office is at 3rd Floor, Sterling House, Langston Road, Loughton, Essex, IG10 3TS ("the Mortgagor") of the other part

WITNESSETH AS FOLLOWS

- As security for the payment of all sums due in an agreement ("the Agreement") dated 5 September 2014 and made between (1) Stephen Ratzker (2) Garry Lucas and Stuart Jacobs (3) Cygnet Street Developments Limited and (4) Galliard Holdings Limited as varied by a Memorandum of Agreement dated 4 December 2014 and a Memorandum of Agreement dated 14 January 2015 both entered into between the same aforementioned parties relating to the sale of the premises known as 91 Sclater Street, 2, 4 and 6 Bacon Street and 7 Cygnet Street, 83-89 (Odd numbers) Sclater Street and 13 Cygnet Street, 9 and 11 Cygnet Street, and 8 and 10 Bacon Street, London (the "Property") the Mortgagor with full title guarantee CHARGES by way of legal mortgage the Property to the Seller
- The monies hereby secured shall become immediately payable without demand and the statutory power of sale shall be exercisable at any time upon the happening of any one or more of the events following that is to say
 - (a) an administration order is made in relation to the Mortgagor, or
 - (b) an order is made and confirmed for the compulsory acquisition of the Property, or
 - (c) a receiver administrative receiver administrator supervisor or trustee is appointed of the Mortgagor or over the property or assets of the Mortgagor or any part or parts thereof, or
 - (d) the Mortgagor certify that it is unable to pay their debts as and when they fall due, or
 - (e) It shall be or become unlawful at any time for the Mortgagor to perform any of the obligations of the Mortgagor herein contained, or
 - (f) the Mortgagor fails to pay any sums due to the Seller under the Agreement when due
- The parties hereto request and authorise the Chief Land Registrar to note on the proprietorship register of the title to the Property the following restriction

"Except under an Order of the Registrar no disposition of the registered estate by the proprietor of the registered estate or by the proprietor of any charge registered after the date hereof shall be registered without the consent of the proprietor for the time being of the Charge dated (3 March + in favour of Stephen Ratzker referred to in the Charges Register"

- THE Mortgagor represents and warrants to the Seller that the execution of this Legal Charge and the observance and performance of the obligations of the Mortgagor to the Seller under this Legal Charge does not contravene any charge mortgage lease loan facility agreement document or (where applicable) or other deed or document whatsoever
- The powers and remedies conferred on mortgagees by the Law of Property Act 1925 shall apply to the security with the variation or extension that on the expiration of one days' notice to the Mortgagor of its intention so to do the Seller may exercise and put in force all and every of such powers and remedies as hereby carried or extended
- The power of sale and the power of appointing a receiver conferred on mortgagees by the Law of Property Act 1925 shall in relation to this security be modified so that they should be exercisable without the necessity of giving any notice in that behalf in the event that the Mortgagor shall commit any breach of any of the obligations herein contained and on the part of the Mortgagor to be observed and performed
