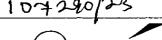

Background

The Borrower has asked to borrow money solely for the purposes of the business carried on by the Borrowers at The Anvil Inn, Pimperne, Blandford, Dorset, DT11 8UN and the Lender has agreed to lend the money on the terms set out in this Bill of Sale

Witnesses that in consideration of the sum of £71,889.49 now paid to the Borrower by the Lender (receipt of which the Borrower hereby acknowledges) the Borrower hereby assigns to the Lender its assigns and successors in title all and singular the several chattels and things specifically described in the schedule annexed hereto ("the Goods") by way of security for the payment of the sum of £71,889.49 ("the Principal Sum") and interest at the rate of 25% a year ("the Specified Rate")

1. Payment
