

UPON THE APPLICATION of the Applicants dated 7 November 2019 (the "Application")

AND UPON reading the First Witness Statement of Zelf Hussain dated 7 November 2019 and its exhibit "ZH1" and other documents that are recorded on the court file as having been read.

IT IS ORDERED that:-

1. Insofar as the Application refers to proceedings not currently before this Court, the proceedings are transferred here for the purpose of this Application and transferred back immediately upon the making of this Order, pursuant to rule 12.37(1) of the insolvency Rules 2016 (the "Rules").

- 2. Ian David Green (the "Outgoing Office Holder") be removed from office as administrator/liquidator, as applicable, of the companies listed in Schedule 2 to this Order, to take effect on the fourteenth day after the date of this Order.
- 3. The Outgoing Office Holder be replaced as office holder in the case of each company listed in Schedule 3 of this Order by the respective Applicants named in the same Schedule (the "Incoming Office Holders"), these replacements to take place on fourteenth day after the date of this Order.
- 4. For the companies listed at numbers (1) to (28) in Schedule 2 of this Order being companies in administration, in accordance with paragraph 100(2) of Schedule B1 to the Insolvency Act 1986 (the "Act"), following the Outgoing Office Holder's removal as administrator, all functions exercised by the (new) joint administrators (as set out in Schedule 2 of this Order) are to be exercised by any one or all of the joint administrators.
- 5. For the companies listed at numbers (29) to (34) in Schedule 2 of this Order being companies in creditors' voluntary liquidation or compulsory liquidation, in accordance with section 231 of the Act, following the Outgoing Office Holder's removal as liquidator, any acts required or authorised under any enactment to be done by the (new) joint liquidators (as set out in Schedule 2 of this Order) are to be done by all or any one or more of the joint liquidators.
- 6. The Applicants shall notify the Secretary of State as soon as reasonably practicable of the making of this Order.
- 7. The Applicants shall be required to notify the creditors of the companies in administration, and creditors' voluntary liquidation ("CVL") (as listed in Schedule 2), of the making of this Order in the following ways only:
 - a. by advertisement in the London Gazette within 28 days following the granting of this Order; and
 - b. by reporting the making of the Order and its effect in the next periodic report sent to all creditors.

The Applicants can publish in the London Gazette composite notices relating to the resignation and the appointments as detailed in Schedule 2 to this Order.

8. The Outgoing Office Holder be discharged from all liability in respect of their acts and omissions and otherwise in respect of their conduct as administrators

of the companies listed at (1) to (28) of Schedule 2 of this Order, being companies in administration, as set out in that Schedule. Such discharge is to take effect 28 days after publication of the advert notifying that the Outgoing Office Holder has vacated office pursuant to paragraph 7 of this Order, and subject to paragraph 10 of this Order, as appropriate.

- 9. In relation to the companies listed at (1) to (28) of Schedule 2 to this Order, being companies in administration, where the Incoming Office Holder is appointed to act as a joint administrator by this Order in circumstances where the Outgoing Office Holder was appointed under paragraph 14 or 22 of Schedule B1 to the Act, that person shall obtain their discharge from liability pursuant to paragraph 98(1) of Schedule B1 of the Act on the same basis as those administrators originally appointed in respect of that company. Accordingly, the discharge provided by paragraph 98(1) of Schedule B1 of the Act will take place, in relation to the Incoming Office Holder, at a time appointed by the resolution of the creditors' committee or, if there is no committee, by resolution of the creditors or in any case at a time specified by the court (and, for the avoidance of doubt, the provisions or 98(3) of Schedule B1 of the Act will apply equally in relation to an appointment made by this Order as it would in relation to the original appointments).
- 10.Permission be granted to each creditor, in respect of the companies (be they in administration, or CVL) listed in Schedule 2 to this Order, as applicable, to apply to vary or discharge this Order by making an application within 28 days after publication of the advertisement notifying that the Outgoing Office Holder has vacated office pursuant to paragraph 7 of this Order.
- 11.In respect of Extra Energy Supply Limited (company (9) listed in Schedule 2 to this Order) and Utility Professional Business Operations Limited (company (27) listed in Schedule 2 to this Order), in the event that the companies move from administration to creditors' voluntary liquidation, Michael Thomas Denny and David Matthew Hammond will be appointed as joint liquidators (as per Schedule 2 to this Order). The administrators will notify the Creditors at the time of the next statutory reporting period of this change to the Statement of Proposals dated 28 January 2019.
- 12.In respect of Caparo Industries Plc (company (3) listed in Schedule 2 to this Order), in the event that the company move from administration to creditors'

voluntary liquidation, David Matthew Hammond and Toby Scott Underwood will be appointed as joint liquidators (as per Schedule 2 to this Order). The administrators will notify the Creditors at the time of the next statutory reporting period of this change to the Statement of Proposals dated 11 December 2015.

- 13.In respect of Phones 4u Group Limited, Phones4u Finance plc, MobileServ Limited, Phosphorus Acquisition Limited (companies (20), (22), (12) and (23) listed in Schedule 2 to this Order), in the event that these companies move from administration to creditors' voluntary liquidation, David James Kelly and Robert John Moran will be appointed as joint liquidators. The administrators will notify the Creditors at the time of the next statutory reporting period of this change to the Statement of Proposals dated 6 November 2014 (the "Group Proposals").
- 14.In respect of Phones 4u Limited (company number (21) listed in Schedule 2), in the event that Phones 4u Limited moves from administration to creditors' voluntary liquidation, David James Kelly, Robert John Moran and Paul David Copley will be appointed as joint liquidators. The administrators will notify the Creditors at the time of the next statutory reporting period of this change to the Statement of the Group Proposals.
- 15.In respect of Phosphorus Holdco Plc (company number (24) listed in Schedule 2) and Policy Administration Services Limited (company number (25) listed in Schedule 2), in the event that the companies move from administration to creditors' voluntary liquidation, Douglas Nigel Rackham and David James Kelly will be appointed as joint liquidators. The administrators will notify the Creditors at the time of the next statutory reporting period of this change to the Statement of the Group Proposals.
- 16.In respect of Maplin Electronics Limited (company number (11) listed in Schedule 2), , in the event that Maplin Electronics Limited move from administration to creditors' voluntary liquidation, Zelf Hussain and Toby Underwood will be appointed as joint liquidators. The administrators will notify the Creditors at the time of the next statutory reporting period of this change to the Statement of Proposals dated 19 April 2018.

17.In respect of Palmer & Harvey (Holdings) plc, Palmer & Harvey McLane (Holdings) Limited, Palmer & Harvey McLane Limited, P & H (1925) Limited, P&H Direct Van Sales Limited, P&H Sweetdirect Limited and P&H Snackdirect Limited (companies numbered (17), (18), (19), (13), (14), (16) and (15) listed in Schedule 2), in the event that the companies move from administration to creditors' voluntary liquidation, Mark James Tobias Banfield and Zelf Hussain will be appointed as joint liquidators. The administrators will notify the Creditors at the time of the next statutory reporting period of this change to the Statement of Proposals dated 18 January 2018.
