UPON the Applicant's Application dated 26 June 2017 ("the Application")

AND UPON the Secretary of State having been duly served with a copy of the application and supporting documentation

IT IS ORDERED THAT

- 1 Each of the County Court cases listed in Schedule 1 ("the **County Court cases**") be transferred to the High Court of Justice, Chancery Division, Companies Court for the purpose only of making this order. Immediately upon this order taking effect, the County Court cases be transferred back to the County Court.
- 2 Garry Wallace Lock ("the **Officeholder**") be removed from office in respect of each of the cases listed in Schedule 2 ("the **Block Transfer cases**") from the date of this order.

- 3 Sean Bucknall, Ian Cadlock, Paul Zalkin, Graham Randall, Andrew Watling, Simon Campbell and Carl Jackson ("the **Replacement Officeholders**") be appointed as replacement officeholders in respect of each of the block transfer cases listed in Schedules 4 to 9 (inclusive) from the date of this order.
- 4 The creditors in each of the Block Transfer cases listed in Schedule 2 be notified of this order by advertisement published in the London Gazette within 21 days from the date of this order.
- 5 Any creditor, or, in the case of any members' voluntary liquidation, any member, in respect of any of the companies listed in Schedule 10 who has an objection to this order shall have 28 days from the date of the Advertisement to apply to court to set aside or vary the terms of this order. Such application shall not affect the transfer of the Block Transfer cases listed in Schedule 10 until further or other order by the court.
- 6 The reporting periods for cases listed in Schedule 2 shall remain in place and the appointment of the Replacement Officeholders will not affect the date the progress reports are to be produced. The Replacement Officeholders will notify creditors or members, in respect of the appointments, of any matters which they believe the creditors or members should be aware of.
- 7 The Replacement Officeholders shall notify the Secretary of State, and the Registrar of Companies in respect of the liquidations and administrations listed in Schedule 2, of the terms of this order as soon as reasonably practicable.
- 8 The Replacement Officeholders shall file a copy of this order with each of the courts listed in Schedule 1.
- 9 Nothing in this order shall release the Officeholder from any obligation to give and file notices in respect of his removal under this order in respect of the block transfer cases listed in Schedule 1.
- 10 In the case of the Administration listed in Schedule 1 appended to this order, the Officeholder be released forthwith from any and all liability past, present or future in respect of any act(s) and or omissions in relation to his conduct as office holder of the estates. Such release to take effect 28 days from the date when the relevant notice referred to in paragraph 4 above has been placed in the London Gazette, save in respect of any claim notified to the Officeholder pursuant to the Insolvency Act 1986 and/pursuant to such other provision as may apply on or prior to the notice date.
- 11 No order as to costs.
- 12 The Replacement Officeholders have the right to apply to the court to amend this order to include any appointments held by the Officeholder which have been inadvertently omitted from this application.
