Pavement 2 Catwalk community interest company (CIC) is a company that reaches out and engages with the disadvantaged and disenfranchised people in our communities.

The company uses a mannequin and recycled materials to create fashion and art. When people attend the workshops, they are sometimes broken and vulnerable, they sometimes say 'I fell like rubbish' so I encourage the group to bring in rubbish or thrown away items and with use of the mannequin, we transfer the rubbish into beauty.

The finished piece is the photographed and then made into artwork or printed onto fabrics and T-Shirts, also dresses and jackets. The ultimate aim is to produce a lifestyle brand using recycled material as the basis for our brand.

Pavement 2 Catwalk has also started using the medium of theatre and music to also inspire the broken and disenfranchised members of the community and after warm reception we received from the play performed in London in May, we are now in the process of forming our own theatre group. The clients gain an understanding of cohesion and working together as a group. Unlike a lot of CIC's we fuse the talents of disabled people with able bodied people on a level playing field, in short does not exclude anyone who is willing to engage with our organisation the results have been astounding when we fuse a survivor of addiction with a client who is partially blind, or a street worker with a survivor of mental health challenges, it's about working together and also learning from each other that's where the magic begins.

This year Pavement 2 Catwalk has focused on the inclusion and integration of survivors of disability, mental health, survivors of addiction, homelessness and new to our project the inclusion of gender.

The play was entitled SOZO (Greek meaning to rescue or to save) the play opened in May and ran for a week. The theatre space was given in kind and we were given a whole week, the response was absolute overwhelming and greatly received by the audience, we are now working on the next version of SOZO. The cast were so engaged with the whole experience that we have now created a SOZO Community.

To keep the momentum going Pavement 2 Catwalk recently created an event entitled I'MPOSSIBLE and bought the cast members together and added an element of youth culture to the piece by collaborating with the Princes Trust and using one of the young people on their project as one of the contributors to our event. This was a community event and was greatly received.

Pavement2Catwalk focused on three distinct areas for workshops this year.

- 1) A collaboration with Turning Point a drug and rehabilitation organisation in Kent Where we held workshops for men who were survivors or being treated for substance addiction.
- 2) Pavement 2 Catwalk also worked a group of senior women in the local community and used their age and experience as a tool in which to engage the younger people who are marginalised in the community.

The sessions were weekly and allowed both groups to create a bond and therefore breaking down barriers and also forming meaningful friendships. The end result was an amazing art exhibition, not just focusing on interesting art pieces, but also allowed the groups to express what they are going through with addiction and also gave the senior women an insight into the people behind addiction the exhibition took place at the Nucleus Art Gallery in Kent and the gallery space was given to us in Kind. The London project started with a collaboration of two joint organisations, Blenheim Real / Turning Point who are based in Kensal rise, with the help of the organisation, they kindly supplied me with a varied selection of clients and service users who have experienced homelessness, drug and alcohol addiction and other challenging issues. After a careful selection process, Pavement 2 Catwalk started work crafting a play that was innovate and extremely brave, as we used the clients/service users as the leads and main characters in the play.

The play was entitled SOZO (Greek meaning to rescue or to save) the play opened in May and ran for a week. The theatre space was given in kind and we were given a whole week, the response was absolute overwhelming and greatly received by the audience, we are now working on the next version of SOZO. The cast were so engaged with the whole experience that we have now created a SOZO Community.
