**ORDER**

---

**UPON THE APPLICATION** dated 9 June 2021 (the “**Application**”)

**AND UPON READING** the witness statement of Mark Jeremy Orton of Interpath Ltd, One Snowhill, Snow Hill Queensway, Birmingham, B4 6GH (the “**First Applicant**”) in his capacity as retiring office-holder of the entities listed in the Schedules dated 9 June 2021

**AND UPON** the proposed replacement office holders having filed statements of being qualified to act as insolvency practitioners and having consented to act as office holders for those appointments listed in the Schedules.

**IT IS ORDERED THAT:**

- 1 Insofar as the Application concerns cases not currently within the jurisdiction of this Court they be transferred to this Court solely for the purpose of and insofar as is necessary for considering the Application and the making of this Order and shall be treated as transferred back without any intervening administrative action forthwith upon the making of this Order.
- 2 Pursuant to paragraphs 63, 88, 91 and 95 of Schedule B1 to the Insolvency Act 1986 (**Act**) and Rule 12.36(2) of the Insolvency (England and Wales) Rules 2016 (**Rules**):
  - (a) Mark Jeremy Orton be removed from office as Joint Administrator of the companies listed in Schedule 1A and Mr Christopher Robert Pole (“**Mr Pole**”) (Chris.Pole@interpathadvisory.com) be appointed as Joint Administrator of those companies;
  - (b) Mark Jeremy Orton be removed from office as Joint Administrator of the companies listed in Schedule 1B and Mr Howard Smith (“**Mr Smith**”) (Howard.Smith@interpathadvisory.com) be appointed as Joint Administrator of those companies.

Mr Pole and Mr Smith having filed statements of being qualified to act as insolvency practitioners and having consented to act as office holders for those appointments, the appointments take effect on the 7<sup>th</sup> day after the sealing of this order.

- 3 The Replacement Officeholders identified and named in Schedules 1A and 1B be appointed as Joint Liquidators of those companies listed in Schedules 1A and 1B in the event that those administrations convert to Creditors' Voluntary Liquidations.
- 4 Pursuant to section 108 and 171 of the Act, rule 12.36(2) of the Rules and regulation 10 of the Limited Liability Partnerships Regulations 2001:
  - (a) Mark Jeremy Orton be removed from office as Joint Liquidator of the companies and limited liability partnership listed in Schedule 2A and Mr Pole be appointed as Joint Liquidator of those companies and the limited liability partnership.
  - (b) Mark Jeremy Orton be removed from office as Joint Liquidator of the companies listed in Schedule 2B and Mr Smith be appointed as Joint Liquidator of those companies.
  - (c) Mark Jeremy Orton be removed from office as Joint Liquidator of the company listed in Schedule 2C and Mr Richard Harrison ("**Mr Harrison**") (Rick.Harrison@interpathadvisory.com ) be appointed as Joint Liquidator of that company.
  - (d) Mark Jeremy Orton be removed from office as Joint Liquidator of the companies listed in Schedule 3A and Mr Nicholas James Timpson ("**Mr Timpson**") (Nick.Timpson@interpathadvisory.com) be appointed as Joint Liquidator of those companies.
  - (e) Mark Jeremy Orton be removed from office as Joint Liquidator of the companies and limited liability partnerships listed in Schedule 3B and Mr Stephen John Absolom ("**Mr Absolom**") (steve.absolom@interpathadvisory.com) be appointed as Joint Liquidator of those companies and limited liability partnerships.

Mr Pole, Mr Smith, Mr Harrison, Mr Timpson and Mr Absolom having filed statements of being qualified to act as insolvency practitioners and having consented to act as office holders for those appointments, the appointments take effect on the 7<sup>th</sup> day after the sealing of this order.

5 Pursuant to section 168(3), (5) and 172 (2) of the Act, rule 12.36(2) of the Rule and article 18 of the Insolvent Partnerships Order 1994:

- (a) Mark Jeremy Orton be removed from office as Joint Liquidator of the firm listed in Schedule 4 and Mr Howard Smith be appointed as Joint Liquidator of that firm.

Mr Smith having filed a statement of being qualified to act as an insolvency practitioner and having consented to act as an office holder for this appointment, the appointment takes effect on the 7<sup>th</sup> day after the sealing of this order.

6 In the case of each entity identified in the Schedules and for the purposes of section 231 of the Act, paragraph 100(2) of Schedule B1 to the Act and all other purposes, the office-holder appointed and the office-holder continuing in office (as identified in those Schedules) are to act jointly and individually and any function or act required or authorised under any enactment or otherwise to be done by the joint administrators and liquidators (as appropriate) may be validly done by either one or all of them.

7 In the case of each entity identified in the Schedules the office-holder appointed or continuing in office (as identified in those Schedules) will cause notice of the change in office-holders:

- (a) to be given to the Secretary of State for Business, Energy and Industrial Strategy as soon as reasonably practicable following the date of this order;
- (b) to be given to the FCA, the creditors and members by way of composite advertisement in the London Gazette within 14 days of the date of this order, such advertisement to include a notice that the FCA, any creditor, or, in the case of any members' voluntary liquidation, any member may within 56 days of the advertisement of

the order make an application to Court to set aside or vary the terms of the order. Such application shall not affect the transfer of the cases listed in the Schedules until further or other order by the Court; and

- (c) to be included in their next written report to the creditors of the estates of the cases listed in the Schedules.

8 Pursuant to paragraph 98(2)(c) of Schedule B1 of the Act, Mark Jeremy Orton shall be discharged from liability in respect of his actions as Joint Administrator of the companies listed in Schedules 1A and 1B:

- (a) if no application is made pursuant to paragraph 12 below, on the date being 56 days from the date of the advertisement referred to in paragraph 7(b) above; or
- (b) if an application is made pursuant to paragraph 12 below, at such time as should be subsequently ordered by the Court.

9 Pursuant to s173(2)(b) of the Act Mark Jeremy Orton shall receive his release as Joint Liquidator of the companies listed in Schedules 2A to 3B on application to the Secretary of State save that such release may be subject to further order in the event of an application by any creditor under paragraph 12 of this order for the specific case subject to that application.

10 Pursuant to s174(4)(b)(ii) of the Act, Mark Jeremy Orton shall receive his release as Joint Liquidator of the companies listed in Schedules 2A to 3B 56 days on application to the Secretary of State save that such release may be subject to further order in the event of an application by any creditor under paragraph 12 of this order for the specific case subject to that application.

11 The Applicants do serve this Order upon the Respondents by email to each of the Respondent's nominated email address.

12 There be liberty for each creditor of the companies listed in the Schedules to apply to vary or discharge this order in so far as it relates to a company of which that person is a creditor (or, as appropriate, member) within 56 days of the publication of an advertisement in relation to that company in accordance with paragraph 7(b) above.

13      There be no order as to costs.

14      There be liberty to apply
