The Sheffield Hardware Hackers and Makers CIC (Sheffield Hackspace) has continued successfully over the last year, maintaining the multiple special interest groups, with "Arts, Crafts and Textiles", "Electronics", "Robotics", "Gaming Night" "3D Printing, CNC and CAD" and "Radio & Mesh Networking" evenings spread across the week. We also have a "Visit the Hackspace" evening for potential members to come and visit the space and speak with members to see what we have to offer, prior to joining. We encourage sharing between the SIGs through attendance at our fortnightly Saturday session, which provides a longer session in the Hackspace. We continue to provide communal workspace and equipment, as well as provide a focal point for sharing ideas, advice and guidance in all things to do with hacking and making. We now have two working 3D printers, to add to the lasercutter, electronics kit and woodworking workshop. Our membership has turned over and we have 19 keyholders and 26 meeting members, as well as some shorter term members from the local community who join to use the facilities for specific tasks. Our online GoogleGroup membership has been reviewed, with all members asked to agree to continued membership of the group in compliance with GDPR. We now have 98 online members, which allows input from a wider geographical area than Sheffield and its surroundings. To continue raising our profile, we have participated in local community events, including the Portland Works Open Up (May), the local Sharrow Festival (July), the Heritage Open Day (September) and the Portland Works Christmas Market (December). We now encourage more participation with visitors, through activities such as racing robots and badge making.

Our stakeholders include our subscribing members, online members and wider local and maker community across Sheffield and the region. To keep in touch with our members and consult with them about the running of the Hackspace at Portland Works, we have a "State of the Hackspace" session once a month, where the trustees report to the members and the members can raise any issues that they have. For our online members, or those who aren't able to make the "State of the Hackspace" on Monday evenings, we tend to send out a brief report of the meeting via email. To inform members of upcoming sessions and events, and to disseminate more widely to the community, we use social media such as our Facebook page (with 269 followers) or Twitter, which has 1914 followers (Feb 2020).

We continue to use the GoogleGroup for email communications and Wordpress (www.sheffieldhackspace.org.uk) to host our website, which details who we are, what we do, where to find us and our calendar of events. It also hosts our blog, where members are able to publish their projects, or link to their own websites, allowing more detailed information on our activities than Facebook and Twitter. Individuals can contact the Hackspace via Twitter, Facebook or through a links on the Wordpress and GoogleGroup websites. We are also members of the Hackspace Foundation, a non-profit organisation that allows Hackspaces across the UK to share resources and knowledge.
