We currently run three sessions a week and in the last few months our membership numbers and income are almost back to pre-covid times.

As of 28 February 2023 we have 57 regularly subscribing members including 20 "keyholder" members who have 24/7 access.

Investment has been made into improving the space:

Our Multi Use Commons Room has had several quality of life improvements:

- 6 Tables replaced increasing the usable space for members.
- Window Blinds Installed.
- Ceiling Mounted Projector added to increase our educational capabilities.

Upgrading of Laser Cutter with a large format version, significantly increasing the size and variety of materials that it can be used with.

Further investment has been put into our workshop room replacing donated tools and a new wood working Bench, with increased storage for tools and member projects.

As a direct result of all of this we are seeing an increased use of all available facilities, and people are joining the hackspace who otherwise wouldn't have done so.

To help serve this community a Discord server has continued operation. The number of users has grown to 105 members (68 last year), it is utilised to announce opening times for both regular and Adhoc events. We have discussion groups for 16 specialist subjects as requested by the community.

Our stakeholders were invited to participate in the improvements to the space (Introduction of new large format laser cutter, New wood working Workbench). Members participation included feedback on desired functionality and participation on installation of the projects/ equipment.

We continually look out for opportunities to seek feedback from our membership and to provide facilities that benefit the community.
