AND IT APPEARING that there is no opposition on behalf of Her Majesty to the relief sought by this Claim as appears from the waiver letter from the Treasury Solicitor dated the 15 November 2019

AND ON the leave of the Court being given to amend the Claim Form (i) to reflect the correct name of the Company as S Gaitens Gas Limited and (ii) to reflect the relief sought as under Section 1029 of the Companies Act 2006 and re-service being dispensed with

AND UPON the Claimant undertaking that:

- (A) the Company will not carry on business or operate in any way other than to take the necessary steps to:
 - (I) realise monies from its bank account referred to in paragraph 10 of the Witness Statement of Stephen Gaitens dated the 5 June 2019;
 - (II) settle all outstanding debts to its existing creditors, if any; and
 - (III) distribute the remaining balance of those monies

(the actions) according to law

- (B) he will notify the Registrar of Companies immediately on the conclusion of the actions
- (C) the director of the Company will immediately on the expiry of 3 months from the conclusion of the actions apply to the Registrar of Companies for the voluntary strike off of the Company under Section 1003 of the Companies Act 2006 and comply with all the relevant requirements for such an application

AND UPON the Claimant and the Registrar of Companies (the Defendant) both consenting to this Order

IT IS ORDERED THAT:

- (1) the name of the above named S Gaitens Gas Limited be restored to the Register of Companies
- (2) if at the date of registration of this Order with the Registrar of Companies the name of the Company is not available the Registrar of Companies shall pursuant to Section 1033(2)(a)(ii) and (b) of the Companies Act 2006 change the name of the Company to 9484943 Limited
- (3) an Office Copy of the Order be delivered to the Registrar of Companies and pursuant to the above mentioned Act the Company is thereupon to be deemed to have continued in existence as if its name had not been struck off
- (4) the Registrar of Companies do advertise notice of this Order in her official name in the "London Gazette"
- (5) the hearing fixed for the 12 December 2019 at 2:00 pm be vacated
