The company produced their annual Folk festival on the Spring Bank Holiday weekend.. It was a successfully implemented event matching previous events staged over the past 44 years.

Attendance was high, both ticketed attendees and general public and was well supported by all in the community.

An impact study has indicated that the local economy benefitted in excess of £1.2M because of the Festival being in the town annually and this was supported by the local authorities own study that corroborates this, stating "A conservative figure of at least £880K".

The benefits of the festival on it's host town is not just financial but also promotes well-being, good social relationships and a binding of all members of the community. A good relationship was maintained with local councils, other organisations and charitable trusts that support the Festival in various ways, including financial. We believe that we are continuing to uphold our commitments made in our initial aims and objectives.

The stakeholders are all that attend the festival (in the region of 25,000) on the weekend including general public who benefit from entry to many free events in and around the town. Local trade, shops, food outlets, accommodation providers and suppliers including fuel, travel to and from the event, food and general everyday supplies, all receive an annual boost by the festival bringing in people from all corners of the UK and beyond.

Whilst there has been no specifically targeted consultation, regular updates, newsletters and media statements are made promoting the festival, its activities in the town and openly inviting comments and suggestions via the festivals web and social media sites.

The organisation regularly conducts questionnaires to keep it updated with opinions although one was not conducted during this year.
