**UPON THE APPLICATION** of the Applicant by application notice dated 7 July 2022

**AND UPON** notice being given to the Secretary of State of this application on 14 July 2022;

**AND UPON** considering the application on the papers;

**IT IS ORDERED THAT:**

1. The County Court case listed in Schedule 1 be transferred to the High Court of Justice, Business and Property Courts of England And Wales, Insolvency and Companies List (ChD) for the purposes only of considering and making this Order and shall be treated as transferred back without any intervening administrative action forthwith upon the making of this Order.
2. Ian Michael Rose ("Outgoing Office-holder") be removed from office, in respect of each of the cases listed in Schedules 1 to 12 ("Block Transfer Cases") of this order, as office-holder from the date of this Order.

3. Matthew Dix ("Replacement Office-holder") be appointed as sole office-holder in respect of the cases listed in Schedules 7 and 8 from the date of this Order.
4. The Replacement Office-holder be appointed as joint office-holder in respect of the cases listed in Schedules 9 to 12 from the date of this Order, and shall be able to exercise any powers individually or jointly with the other office-holder.
5. The creditors and members in respect of each of the Block Transfer Cases be notified of this order:
  - 6.1. by way of an advert in the London Gazette within 14 days of the date of this order, and;
  - 6.2. by reporting the making of this order and its effect in the next periodic report to creditors/members.
6. Any creditor or member who has an objection to this order shall have 28 days from whichever is sooner of 6.1 or 6.2 above, to apply to the Court to set aside or vary the terms of this order. Such application shall not affect the transfer of the Block Transfer Cases until further or other order by the Court.
7. The Replacement Office-holder shall, as soon as reasonably practicable, give notice of this order to:
  - a. the recognised professional body of each of:
    - i. the Outgoing Office-holder;
    - ii. the Replacement Office-holder;
  - b. the Registrar of Companies
  - c. the Secretary of State
8. Liberty to the recognised professional body and the Secretary of State to apply to the Court to set aside or vary the terms of this Order upon giving written notice to the Parties. Such application shall not affect the transfer of the Block Transfer Cases until further or other order by the Court.
9. The Replacement Office-holder shall file a copy of this Order with the Courts listed in Schedules 1 to 12 as soon as reasonably practicable.
10. The Outgoing Office-holder shall vacate office upon the making of this order.
11. No order for costs.
