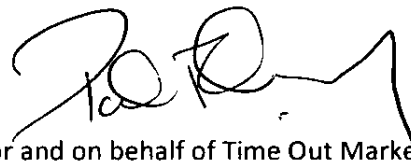
Ordinary Resolution
