The company is in the process of building 34 cohousing homes in the city of Norwich. These will be the first such development in the city. They are to be constructed on a brown field site and will be high quality energy efficient homes designed and built for and by local people.

In the past year the group has consulted frequently with its members both in person and via Zoom meetings. The meetings have related to building design and the practicalities of living together in a cohousing community. With the help of the various consultants engaged by the group, the plans for the project were progressed up to the stage of submission to the local authority for planning permission.

Meetings are held at least monthly with all members able to attend. These are to develop and drive the project forwards. There are weekly steering group meetings the minutes of which are distributed to all members for feedback if necessary. In addition there has been consultation with members of the community living adjacent to the site to be developed. This has involved door knocking and a community consultation weekend held at the local parish hall. Here views were canvassed and these contributed to the final package presented to the local authority for planning approval
