PART 1 - GENERAL DESCRIPTION OF THE COMPANY'S ACTIVITIES AND IMPACT

Lads Need Dads CIC is a Not-For-Profit Community Interest Company based in Tendring, North East Essex, founded in June 2015, which seeks to empower and enable boys age 11-15 with absent fathers or limited access to a male role model, to be motivated, responsible, capable, resilient and emotionally competent to prevent them becoming at risk of under achieving, offending, exclusion or dropping out of school.

Our Aims are to:

- Help boys through male-led group mentoring, to cope with problems and issues faced at home and school and explore the important choices they face in their adolescent development, to prevent escalation of negative behaviour.
- Provide boys the opportunities for adventure and to be tested and challenged, both physically and mentally.
- Provide on-going support, life-skill training, and volunteering opportunities.
- To raise awareness and understanding of the important role fathers play in the emotional, mental and educational development and well-being of boys.

We meet our aims by providing an 18-month long term early intervention programme called Equip, Engage and Inspire.

'EQUIP', is a six-month self-development group-work programme held in school including bush-craft and outdoor activities supported by a facilitator and a team of male mentors. Equips' aim is to help boys cope with problems and issues faced at home and school and explore the important choices they face in their adolescent development, to prevent escalation of negative behaviour.

Engage, a practical life-skill and community volunteering programme follows Equip and takes place in the community for six-months and involves boys attending practical life-skill workshops and together with thier mentors, doing voluntary work for lone parents, pensioners and people with a disability within their local community. Jobs include, DIY, painting and decorating, gardening, shed building, etc.

Inspire, a peer mentoring programme incorporating inspirational speakers and visits to inspiring places, and leadership opportunities, completes the 18-month programme.

We have an open-ended group called Ambassadors for graduates of the programme to attend.

Alongside the programmes we provide on-going support for mums and carers via workshops, coffee mornings and a face-book support group and conflict mediation. We also introduced a Family worker role in 2020 to support the mums and carers during lockdown and this has continued. We raise awareness within the community by giving talks and presentations to community groups, attending public events etc.

In the reporting period of 2019 (July) to 2020 (June) Lads Need Dads have run six programmes; two Equip, two Engage, one Inspire and one Ambassador cohort. Equally we work with the parent and carer providing regular weekly support.

In addition to the volunteer mentor training we provide, during this reporting period we have trained our mentors in **Mental health First Aid and Safeguarding level two.**

The team of mentors stood at 18 at the time of this reporting period.

Our work was recognised both locally and Nationally during this reporting period. We have been shortlisted for the National Diversity Award and won the Queens Award for Voluntary Service (equivalent to an MBE).

Lads Need Dads always carry out surveys with each school we deliver our programme to, to assess need. We advertise on social media to attract referrals and do outreach campaigns in public places. We work closely with parents, outside agencies and schools to identify pupils.

The boys who took part in the pilot of 2019/20 were consulted with regularly and helped shape some of the content of the programme. Parents and carers are consulted with quarterly for feedback regarding their opinion on our service.

In response to COVID 19 and lockdown our services turned remote. Boys were each allocated a mentor to provide on-line mentoring sessions, talk and walk sessions when coming out of lockdown and remote session in cooking, crafts and guitar. We also started a new pen-pal initiative matching boy to elderly men in care homes. We had remote Inspirational speakers on our Inspire Programme from around the country and from Canada.

Future plans

Our managing Director joined the Men and Boys Coalition as a Trustee during this reporting period, which highlights and tackles issues where the needs of men and boys are unmet. Our MD contributed to a ten-point policy measure forwarded to Government to support the wellbeing of men and boys in the UK regarding recognising boys with absent fathers as having an additional need. Lads Need Dads are to carry out research in Essex schools over the next twelve months to gather data regarding boys with absent fathers, and explore how school policy could include boys with absent fathers as disadvantaged and look at implementing a flagging system to enable boys to be identified and supported early. We are also expanding into another area of Essex, Harwich a area of deprivation and an area yet to benefit from our intervention.
