The company continued our work with Communities, Statutory, Voluntary & Community Groups and Residents within Birmingham. Our main aims are to improve Community Engagement, Integration & Cohesion, Health & Well-Being, Boxing Skills and the Reduction in Social Isolation & Loneliness and Crime. We concentrated working in some of the most deprived areas within Birmingham; Meadway, Lea Hall, Glebe Farm, Tile Cross, Castle Vale, Garretts Green and Sheldon.

Last year our business and our clients were impacted via the Government Lockdown Measures; we had to re-adapt some of the ways we worked with our clients; which benefitted some of our clients but not others. With restrictions lifted we were able to get our services delivered as usual face to face in settings within the Community.

This year we were able to secure funding to deliver a Neighbourhood Club in Castle Vale; and to continue delivering our Meadway Neighbourhood Club via the National Health Lottery Connections Fund. These clubs are much welcomed via our clients who participate in them; they said it helps them with social isolation, loneliness and mental health problems via meeting up with others; having someone to talk to, socialising and having fun.

We secured funding via the 'This Girl Can Fund' to deliver a 'Womens Boxing & Fitness Club' in partnership with local organisations Kings ABC and Sheldon Community Centre; this is one of the things listed via our clients that they said was needed in their area; it is well attended and hopefully, we will continue with these sessions.

We are also working in partnership with the Glebe Farm Trust CIC delivering a research and development Project within the Glebe Farm & Tile Cross Ward of Birmingham; this is a 2 year Commissioned Project. Hopefully, the Community who are helping us with this Project will benefit via highlighting what is needed in their area and making these improvements and ideas a reality.

There is still a lot of work we need to do within the Communities we are working in currently; Garretts Green, Glebe Farm & Tile Cross and Castle Vale Wards of East Birmingham. The feedback from our clients is they are benefitting from the work we are delivering within their Communities and they want this to continue in the future.
