This report should be read in conjunction with my report and proposals for achieving the purpose of the administration of the above company sent to creditors on the 26th May 2017 and the first progress report dated 20th October 2017.

By order of the High Court of Justice dated 21st February 2018 the administration was extended until the 31st March 2019

2. **Asset Realisations**

A Chattel Assets and Stock

All chattel assets have been realised as set out in my first report to creditors. I have not been made aware of any additional chattel assets and do not expect to make any further recoveries of this nature.

B Rent Deposits

The Company rented various residential properties for members of staff domiciled abroad but requiring a base when working in the UK. All tenancies have now expired or been terminated and I have recovered the sum of £5,107 in respect of deposits lodged with landlords' agents as a condition of the granting of the tenancies.

C Cash and Interest

Following the administration of the Company and the continued involvement of Claire Swan, she retained a small petty cash fund. Following Claire's death, I have recovered the sum of £46.06 from that petty cash fund.

Bank interest of £330.59 has been received on monies held by me in the administration.

D LINDE Contract - Manchester

As previously reported, the Company was involved in a contract to construct a bio-mass plant at Manchester on behalf of LINDE. Whilst the contract was substantially completed, some final works were required which were undertaken by Ditecsa SA Limited, the holding company of Ditecsa UK Limited. The works have now been finally concluded. I instructed quantity surveyors Cooper & Hall, to deal with the claim for payment from Linde on my behalf. As a result of their efforts, LINDE made an interim payment of £279,170 and a subsequent payment of £92,239.17. There is a retention of 66,851 euros (namely 5% of the contract) as a warranty bond. These funds are due to be released (subject to any warranty claims) in September 2018.

Without the assistance of Ditecsa SA, this contract could not have been completed and the Company would have faced contractual claims from Linde. The costs incurred by Ditecsa SA in completing the works have now been received and are being verified by our quantity surveyors. The costs of completing the contract from the 31st March 2017 to its completion will be an expense of the administration.

E SIRO (CEREALTO) Contract - Worksop

The main purpose of the administration is to enable the Company to pursue an adjudication in respect of a contract undertaken by the Company at a site in Worksop with SIRO UK Limited (now rebranded CERALTO UK Limited).

I have appointed the abovenamed Cooper & Hall to quantify the Company's claim and prepare the supporting evidence and documentation for the purposes of the adjudication.

I also retained the services of Claire Swann a former employee of Ditecsa UK Limited to assist Cooper & Hall in their efforts to formulate the claim. Sadly Claire died in October 2017 which has resulted in a significant increase in the involvement of Cooper & Hall to collate the evidence and claim.

I have also instructed Hawkswell Kilvington solicitors to pursue the adjudication on behalf of the Company. The claim is currently due to be considered by the adjudicator in May 2018 who will give directions on any additional information he requires before giving his judgment on the opposing claims.

The claim is extensive and complex and has resulted in a number of progress and strategic planning meetings being necessary between myself and the professionals concerned. It was decided that before the matter progressed to formal adjudication, the claim should be discussed quantity surveyor to quantity surveyor with a view to narrowing down the issues in dispute to be determined at the adjudication.

The formulation of the claim has also involved various members of staff of Ditecsa SA who were involved in the contract. An additional expense of the administration will be the cost of co opting the involvement of Ditecsa SA and its staff. Various meetings have been necessary to understand the mechanics of the contract and legal obligations and requirements of both parties to the building works

The quantity surveyors investigations have brought to light the following issues:

- 1 The scale of the difference between the works originally contracted to be supplied by the Company for the project and the variations and extras subsequently requested by SIRO UK Limited is significant. It is anticipated that the Company's claim will be significantly in excess of the £1,174,264 estimate referred to in the statement of affairs. It would be premature at this stage to attempt to quantify the level of the claim but suffice it to say it is substantial and if adjudication is in the Company's favour and monies recovered, it will be of significant advantage to creditors.
- 2 The claim has been complicated by the premature termination of the contract by CEREALTO UK. The Company's claim consists of a combination of:
 - a) Claims for works completed under the original contract which remain unpaid.
 - b) Claims for damages for the premature termination of the contract.
 - c) Claims for variation works completed but not paid for.
 - d) Claims for damages for variation works contracted to be done but not completed due to the premature termination of the contract
- 3 My quantity surveyors have identified approximately 450 variations to the original contract. The claim has involved my quantity surveyors trawling through thousands of e mails and notes to understand the nature of the variations, their impact on the original works completed or partially completed and the agreed costs implications of such works or where there was no specific agreement the valuation of the costs on a quantum meruit basis. Creditors should not underestimate the extent of the task of putting it in order and quantifying the level of the claim.
- 4 Discrepancies have become apparent in relation to some subcontractors claims for works undertaken. These discrepancies may have an effect on the ultimate level of claims to be admitted in the administration. The frustration of some creditors has centred around my quantity surveyor's inability to agree their claims. Unfortunately many of the claims are tied into the claim against Cerealto UK and cannot be determined in isolation. There is also an issue whether Cerealto have paid sub contractors direct in relation to works done under the contract (which should be paid to the Company not the subcontractors' direct) and what works have been completed by the subcontractors direct with Cerealto since administration for which they have been paid and for which they should not be paid a second time as part of their claim in the administration.

As mentioned above, due to the magnitude of the claim, the parties quantity surveyors have entered into discussions with a view to agreeing as much as possible and narrowing the adjudication to the issues actually in dispute. The quantity surveyors are now holding regular monthly meetings to consider progress and to deal with outstanding queries and to bring to the opposite side any additional issues which have been brought to light in the intervening month.

Creditors

Secured

There are no secured creditors

Preferential

Whilst the director's estimated statement of affairs anticipated arrears of pay/holiday pay to be approximately £3,000, no claim has yet been received. This may be due to the fact that the Company had only one employee as at the date of the administration and as indicated earlier she was retained by the Company up to her death in October. Consequently it is anticipated that there will be no claim by this class of creditor.

Unsecured

The director's statement of affairs anticipated claims in the region of £4,653,156. To date I have received claims totalling £3,389,034. The following issues remain outstanding:

- 1 Claims are being verified by the quantity surveyors and I reserve the right to challenge any overstated claim.
- 2 The above figures do not include the claim from Ditecsa SA. Ditecsa SA have informed me that SIRO had obtained a performance bond from Banco Santander which SIRO have enforced, Banco Santander has made payment as required by Spanish law and Ditecsa SA has been required to reimburse the bank under its guarantee. The amount guaranteed was £550,000. Ditecsa SA's claim both at unsecured and administration expense level is still being resolved.

3. Administrators' Remuneration

My post appointment time costs are reflected in the attached Statement of Insolvency Practice 9 time costs summary and total £111,037. I have not drawn any fees on account against these costs to date.

If I anticipate that the fees will exceed the original assessment of £125,244, I will revert to creditors at the appropriate time.

As reflected in the attached receipts and payments account, I have also made various payments over the past six months in relation to disbursements, including legal fees to Hawkswell Kilvington Solicitors and Wilkinsons Solicitors in a total sum of £2,636, quantity surveyor fees to Cooper & Hall of £77,028, insurance costs (employer liability insurance) to Marsh of £112 and a bond of £490

In addition, up until her death I retained the services of Claire Swann. I incurred additional direct salary costs of £2,125 plus £791PAYE/NIC together with her expenses (rent and telephone) together with an additional £150 paid to the Company's accountants to maintain the payroll for this employee. Furthermore as I required her to be based at the quantity surveyors' offices in

Tadcaster, I incurred rental costs of living accommodation for her in the total sum of £5,500.

4. Conclusion

I trust the above is self-explanatory although should you require any further information, please do not hesitate to contact me. In the meantime, I can confirm that the Administration Order will automatically end on 30th March 2019. I will report to creditors following the next six monthly update report in October 2018. However as this administration is focussed on the adjudication, I will report further to creditors when the adjudicator has given his ruling.
