- (A) inform the Registrar of Companies of the title and Court reference
number of the litigation against the Company seeking damages for
alleged professional negligence arising out of a contract to provide
professional legal services to the Claimant referred to in paragraphs 9
and 10 of the Witness Statement of Deborah Weller dated the 23 May
2023 immediately after issue
- (B) inform the Registrar of Companies immediately on the conclusion of
the said litigation insofar as it is against the Company or of any appeal



therefrom or o the conclusion of the claim against the Company by
any other means

AND UPON the solicitors for the Claimant and for the Registrar of Companies
(the Defendant) both consenting to this Order

IT IS ORDERED THAT:

- (1) the name of the above named The Foster Partnership Limited be
restored to the Register of Companies
- (2) the Company do continue in Compulsory Liquidation
- (3) the Claimant do serve a copy of this Order on the Official Receiver
within 21 days of the date hereof
- (4) if at the date of registration of this Order with the Registrar of
Companies the name of the Company is not available the
Registrar of Companies shall pursuant to Section 1033(2)(a)(ii)
and (b) of the Companies Act 2006 change the name of the
Company to 09730960 Limited
- (5) an Office Copy of the Order be delivered to the Registrar of
Companies and pursuant to the above mentioned Act the
Company is thereupon to be deemed to have continued in
existence as if its name had not been struck off

(6) the Registrar of Companies do advertise notice of this Order in her official name in the "London Gazette"

(7) the Claimant do pay to the Registrar of Companies her costs of the said Application in the agreed sum of £300-00

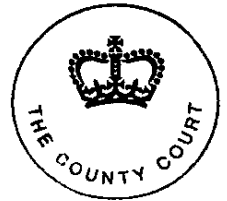
(8) the hearing fixed for the 9th November 2023 at 4:00 pm be vacated
