(b) on a return of capital, the first £200,000 of proceeds shall be distributed amongst the holders of the 'A' ordinary shares, the 'B' ordinary shares and the 'C' ordinary shares, with the balance distributed amongst the holders of ordinary shares in proportion to the number of shares held by them regardless of class.
