ORDER

Before Deputy District Judge Bradshaw at Birmingham Civil Justice Centre, 33 Bull Street, Birmingham, B4 6DS on 18th December 2023

UPON the petition of StreetTeam Software Limited acting by its administrators Matthew Ingram and Philip Dakin of 4b Cornerblock 2 Cornwall Street, Birmingham, West Midlands, B3 2DX (the **Joint Administrators**) presented to this court on 18 December 2023

AND UPON reading the First Witness Statement of Matthew Ingram dated 20 November 2023

AND UPON hearing Counsel for the Applicant

AND UPON the Court being satisfied that the proposed liquidators have filed a statement of qualification and consent to act as liquidators of the Company

AND UPON the Court being satisfied on the evidence before it these proceedings are COMI proceedings as defined in Rule 1.2 of the Insolvency (England and Wales) Rule 2016

IT IS ORDERED THAT:

1. The appointment of the administrators of StreetTeam Software Limited t/a Pollen (the **Company**) dated 16 August 2022 on 16 August 2022 shall cease with effect from 12pm on 18 December 2023;
2. Matthew Ingram and Philip Dakin be released as Joint Administrators under paragraph 98 to Schedule B1 to the Insolvency Act 1986 with effect from 12pm on 18 December 2023;
3. The requirement for a directions hearing under Rule 7.31 of the Insolvency (England and Wales) Rules 2016 be dispensed with;

1. The requirements for service and advertisement of the Petition be dispensed with;
2. The Company be wound up by the Court under the provisions of the Insolvency Act 1986 with effect from 12 pm on 18 December 2023 2023;
3. Matthew Ingram and Philip Dakin of 4b Cornerblock 2 Cornwall Street, Birmingham, West Midlands, B3 2DX, the Joint Administrators of the Company be appointed as Joint Liquidators of the Company under Section 140(1) Insolvency Act 1986 with effect from 12 pm on 18 December 2023.
4. Any act required or authorised under any enactment to be done by a liquidator may be done by either or both of the joint liquidators in accordance with section 231 of the Insolvency Act 1986;

AND IT IS ORDERED THAT the costs of the winding up petition be paid as an expense of the liquidation of Company.
