During the last financial year we have faced our biggest challenge yet, in the history of the club, as everyone did, in our sector, in the wake of a pandemic. Our performance activities were put on hold, however, as restrictions lifted in the Summer of 2021, we produced and performed our first concert since the pandemic. Reflecting on Covid, our concert 'The Year That Wasn't' told the story of how the pandemic had affected us all, in songs, dance, drama, music, multi-media and poetry.

Our relationships with other organisations and venues, continues to grow, which has included; the Kings Theatre (Gainsborough),the Majestic Theatre (Retford), the YMCA (Lincolnshire) and LCVYS. As for venues, we have established new relationships with our local churches as places to perform and support through attending and supporting their community events, whilst also re-establishing our relationship with the Old Nick Theatre, Gainsborough.

A promising future awaits us, with membership of the club increasing week on week, and a clear five year plan, in place. Through the pandemic, we have been fortunate enough to be able to offer 1 2 1 and small group support to young people, and we continue to do this face to face now. This has not only supported the club, but, most importantly volunteers and young people's mental health and wellbeing.

The Arts Award Course will also be returning to PACS, as we have participants now signed up for both the Silver (Level 2) and Gold (Level 3) awards, whilst also continuing to offer our Expressive Arts ASDAN, and Mentoring older members. It is also hoped, that as we move in to 2022/23 there will be more opportunities to extend our provision to include Musicianship and Live Music Performances.

All of our activities continue to evolve, supporting the community, develop the skills of young people and offer mentoring and volunteering opportunities also.
