The SENS Network exists for the benefit of new and existing social enterprises - from fledgling/emerging initiatives to well established businesses.

The overarching aims of SENS are

- Provide focussed networking opportunities to foster the sharing of expertise & information, and to support each other
- Develop a stronger voice for greater support for social enterprise activity in Somerset
- Raise awareness of the potential of social enterprise to contribute to the rural economy, environment & local communities
- Demonstrate how social enterprises can offer a wide range of cost-effective services, offer sustainable solutions to local problems and promote the reduction of carbon emissions

Over the reporting period SENS achieved the following:

- 24 participants attended start up training session; 80% good or excellent feedback;
 50% change of behaviour as a result (3 month follow up)
- SENS held 4 network meetings attended by 55 people overall
- Number of members: (The aim was to attract 100 members in the first year of SENS.)
 We now have 160 members of the SENS Meetup Group and 60 (free) 'paper' members
- Launched a SENS website including online directory live
- Agreed the legal form & incorporation as a CIC completed
- A strong and vibrant membership that supports other members: this has been
 evidenced at peer-to-peer network meetings and training events; also a number of
 testimonials received regarding new collaborations and new volunteer mentoring
 relationships
- SENS included in a Heart of the South West Local Enterprise Partnership bid to the European Regional Development Fund to support social enterprise (subsequently successful)

These activities represent huge achievement for the Social enterprise sector across the county. There had previously been a lack of support for the sector and it is recognised as being a valuable contributor to the economic growth and stability of the region and in encouraging entrepreneurial individuals to be able to act of their ideas.

The aim of social enterprise is clear and fosters diversity and equality of opportunity, transparency, a spirit of collaboration and co-operation and respect for others and tolerance of different views. It is also acknowledged that social enterprise employs more local people with 84% of social enterprises actively recruit staff locally, and 52% employ those who are disadvantaged from the labour market.

One of the members of SENS is the Somerset Micro-providers project which has encouraged the set up of over 220 micro providers offering a huge range of support for people to remain independent at home for longer and be able to actively take part in their local communities.
