Under that law the directors have elected to prepare the financial statements in accordance with applicable law and United Kingdom Accounting Standards (United Kingdom Generally Accepted Accounting Practice), including Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland'. Under company law the directors must not approve the financial statements unless they are satisfied that they give a true and fair view of the state of affairs of the company and of the profit or loss of the company for that period.

In preparing these financial statements, the directors are required to:

- select suitable accounting policies for the company's financial statements and then apply them consistently;
- make judgements and accounting estimates that are reasonable and prudent; and
- prepare the financial statements on the going concern basis unless it is inappropriate to presume that the company will continue in business.

Going concern

<u>Due</u> to the extraordinary situation of the Covid-19 pandemic the Board continues to assess a series of scenario plans and cash flow forecasts. These forecast scenarios include potential significant impact to revenue, client payment delays and limited recovery of fixed costs. The Company has maintained a strong liquidity position during the Covid-19 pandemic, in line with the prior year. This position was supported due to the timely and decisive actions of the Board and by utilising Government initiatives such as PAYE and CIS payment deferrals and utilising the job retention scheme.

To further ensure there is sufficient liquidity the Group has secured a £5m revolving credit facility from Lloyds under the Coronavirus Large Business Interruption Loan Scheme (CLBILS) and has also secured a £5m a trade supplier finance facility.

The Company is in fully operation across all its construction sites, ensuring that the correct social distancing and all Government guidelines are adhered to. With the commitment of a highly skilled and dedicated workforce, close collaboration with our customers and supply chain partners, we continue to adjust to the evolving challenges of this global pandemic.

The board is confident of the Company's ability to survive the current challenges and therefore consider it reasonable to assume that the Company has adequate resources to continue for the foreseeable future and, for this reason, have continued to adopt the going concern basis in preparing these financial statements.
