#### 1. STATUTORY INFORMATION

Boba Commodities Willow Limited is a private company, limited by shares, registered in England and Wales. The company's registered number and registered office address can be found on the Company Information page.

#### 2. ACCOUNTING POLICIES

#### Basis of preparing the financial statements

These financial statements have been prepared in accordance with the provisions of Section 1A "Small Entities" of Financial Reporting Standard 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland" and the Companies Act 2006. The financial statements have been prepared under the historical cost convention.

#### Going concern

The company's balance sheet presents net liabilities of £711,966. On the basis of a letter of support received from the directors of a related company Boba Commodities Limited which provides financial support to meet the company's liabilities as they fall due for at least one year from the period of signing these financial statements and enquiries made of the directors of Boba Commodities Limited, the company's directors have a reasonable expectation that the company will be able to continue in operational existence for the foreseeable future. Accordingly, the annual financial statements continue to be prepared on a going concern basis.

#### Turnover

Turnover represents gains net of losses made as a result of trading in commodities and other financial derivatives.
