This authority revokes and replaces all unexercised authorities previously granted to the Directors but without prejudice to any allotment of shares or grant of Rights already made or offered or agreed to be made pursuant to such authorities.

SPECIAL RESOLUTION

- 2. THAT, subject to the passing of resolution 1 and in accordance with article 3.1 of the articles of association of the Company (Articles), the Directors be generally empowered to allot equity securitles (as defined in section 560 of the CA 2006) pursuant to the authority conferred by resolution 1, as if articles 10.2 and 10.3 of the Articles did not apply to any such allotment, provided that this power shall.
 - a. be limited to the allotment of equity securities up to an aggregate nominal amount of £29.10; and
 - b. expire on the fifth anniversary of the date of passing of these resolutions (unless renewed, varied or revoked by the Company prior to or on that date), save that the Company may, before such expiry make an offer or agreement which would or might require equity securities to be allotted after such expiry and the Directors may allot equity securities in pursuance of any such offer or agreement notwithstanding that the power conferred by this resolution has expired
