ManHealth was founded by Paul Bannister. Paul felt that men were more likely to share their experiences of mental health through peer support. The CIC was created in response to the lack of services, or knowledge available to help men with their mental illness and to address the health inequalities in men in the UK.

ManHealth's vision and mission statement was updated in 2020 to better reflect where we are now.

Our Vision:

• To play a vital role in supporting men and building healthy communities.

Our Mission:

ManHealth empower men experiencing mental and/or physical ill health through support, education and shared experience. We campaign to raise awareness, improve understanding and promote good health.

Research has shown that peer-run self-help groups yield improvement in psychiatric symptoms resulting in decreased hospitalisation, larger social support networks and enhanced self-esteem and social functioning.

In 2020 despite the pandemic ManHealth continued to support many men across our region through the delivery of our peer support groups. In 2020 ManHealth introduced an additional service with support from the various funders. Our Webchat and Connect service supports men online as is accessible 7 nights a week via our website 6-10 pm. ManHealth also continued providing training throughout 2020.
