

ORDER

UPON THE APPLICATION for a Block Transfer Order by Application Notice dated 14 December 2022

AND UPON reading the evidence filed in support of the Application

AND UPON Michael Chamberlain consenting to be removed from office as the joint insolvency officeholder in respect of the cases referred to in the Application and annexed to this Order as Schedules A and B

AND UPON Gareth Peckett consenting to be removed from office as the joint insolvency officeholder in respect of the cases referred to in the Application and annexed to this Order as Schedule B

AND UPON THE COURT being satisfied that it is expedient to transfer all of the cases listed in Schedules A and B in which Michael Chamberlain holds office and all the cases listed in Schedule B in which Michael Chamberlain and Gareth Peckett hold office

AND UPON hearing from Philip Currie of Counsel for the Applicants

IT IS ORDERED THAT:-

1. Michael Chamberlain be removed from office in respect of each of the cases listed in Schedule A (attached to this order) from the date of this order and be replaced by Simon James Bonney and Michael Colin John Sanders jointly (the "**Replacement Officeholders**").
2. Michael Chamberlain and Gareth Peckett (the "**Outgoing Officeholders**") be removed from office in respect of the cases listed in Schedule B (attached to this order) from the date of this order and be replaced by Simon James Bonney and Michael Colin John Sanders jointly.
3. In respect of each of the matters listed in Schedules A and B (the "**Block Transfer Cases**"), the creditors shall be notified of this order solely by way of one composite advertisement published in the London Gazette ("Advertisement") within 21 days of receipt of the sealed Order from the Court.
4. Any creditor in respect of any of the Block Transfer Cases who has an objection to this Order shall have 21 days from the date of Advertisement to apply to the court to set aside or vary the terms of this Order. The time period shall run from the date of

Advertisement. Such application shall not affect the transfer of the Block Transfer Cases until further or other order by the court.

5. The Replacement Officeholders appointed further to paragraphs 1 to 2 of this order shall give notice of the terms of this Order to the Secretary of State and the Registrar of Companies in respect of the Block Transfer Cases as soon as reasonably practicable.
6. Nothing in this order shall release the Outgoing Officeholders from any obligation to give and file notices in respect of their removal under this order concerning the Block Transfer Cases.
7. In respect of each of the matters listed in Schedule A, the Outgoing Officeholders shall be released forthwith from any and all liability past, present or future in respect of any act(s) and/or omissions in relation to their conduct as Outgoing Officeholders of the estates. Such release shall take effect 28 days after the notification requirements set out at paragraphs 3 and 5 above have been fulfilled, save that such release may be subject to further Order in the event of an application by any creditor under paragraph 4 above for the specific case subject to that application.
8. There shall be No Order as to costs.
9. Nothing contained in paragraph 8 shall prejudice the Respondents from charging to each of the Block Transfer Cases the cost of obtaining an insolvency practitioner's security bond in respect of those cases.
