1 Statutory information

The Square Royale Limited is a private company, limited by shares, registered in England and Wales, registration number 10014389. The registered office is 41 Aeron Place, Gilfach, Bargoed CF81 8J.

2 Compliance with accounting standards

The accounts have been prepared in accordance with the provisions of FRS 102 Section 1A Small Entities. There were no material departures from that standard.

3 Accounting policies

Basis of preparation

The accounts have been prepared under the historical cost convention as modified by the revaluation of certain fixed assets.
