**SPECIAL RESOLUTION**

1. **THAT** the Company's articles of association be and are hereby amended by the insertion of a new Article 26(6) beneath Article 26(5) as follows and the remaining articles shall be renumbered accordingly

**26(6). Transfers to a bank or institution**

Notwithstanding anything contained in these Articles, the directors shall not decline to register any transfer of shares, nor may they suspend registration thereof, where such transfer is

(i) in favour of any bank or institution (or any nominee or nominees of such bank or institution) to whom such shares are being transferred pursuant to any security, or

(ii) executed by any bank or institution (or any nominee or nominees of such bank or institution) to whom such shares shall have been transferred as aforesaid pursuant to the power of sale under such security or any other enforcement under such security, or

(iii) duly executed by a receiver appointed by a bank or institution (or any nominee or nominees of such bank or institution) pursuant to any security document which creates any security interest over such shares,

and a certificate by an official of such bank or institution (or any nominee or nominees of such bank or institution) or any such receiver that the shares are or are to be subject to such security and that the transfer is executed in accordance with the provisions of this Article shall be conclusive evidence of such facts
