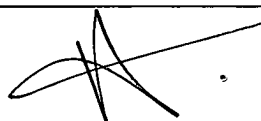

Approval can only be withheld by the Directors if the transfer would result in adverse regulatory, pecuniary, legal, taxation or material administrative disadvantages for the company or the holders of the preferred shares as a whole. On completion of the project the company's profits will be applied in order of priority: - first - to repay to preferred shareholders an amount equal to the subscription monies; - secondly - to make payment of the balance split according to the share holdings between preferred and ordinary shareholders. Shareholders of each class are entitled to receive payment pro-rata within that class.
