

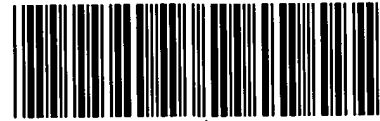

**LIQUIDATOR'S PROGRESS REPORT PURSUANT TO SECTION 92A OF THE INSOLVENCY ACT 1986  
AND RULE 18.3 OF THE INSOLVENCY (ENGLAND AND WALES) RULES 2016**

Further to my appointment as Liquidator on 12 December 2019 I report on the progress of the liquidation for the Period 12 December 2021 to 11 December 2022 ("the Period").

I attach:

- Appendix A – Receipts and payments account for the Period and cumulative
- Appendix B – Details of my disbursements for the Period
- Appendix C – Statement of expenses incurred in the Period

**1. Progress of the Liquidation**

I summarise below details of work undertaken during the Period of this report together with a summary of work still to be completed.

- Administering the estate bank account.
- General correspondence with the shareholders to provide updates on the progress of the liquidation.
- Seeking confirmation from HM Revenue & Customs ("HMRC") that there are no outstanding pre-appointment Corporation Tax Returns or payments due together with tax clearance.
- Providing the annual statutory progress report to shareholders and filing same with the Registrar of Companies.
- Case accounting.
- General administration and case progression reviews.

Outstanding matters to complete in the period following this reporting period are summarised below:

- Making a final distribution to shareholders.
- Dealing with all post-appointment tax including post appointment final Corporation Tax Returns, payment of any Corporation Tax liability and final post appointment Corporation Tax clearance.
- Providing the annual statutory progress report to shareholders and filing same with the Registrar of Companies.
- All matters to bring the liquidation to a close including, payment of any final disbursements, closing the liquidation bank account, providing a draft final account and subsequent final account to shareholders' filing the final account at Companies House and cancellation of the bond.
- General administration.

Attached at **Appendix A** is a Receipts and Payments account detailing both transactions for the Period and also cumulatively since my appointment as Liquidator.

## **2.Dividends to Creditors**

### ***Preferential Creditors***

There are no preferential creditors in this matter.

### ***Unsecured creditors***

Notice for creditors to submit their claims in the liquidation was advertised in the London Gazette and no claims were received.

It was understood there were no unsecured creditors in this matter but as noted under progress of the Liquidation a penalty notice was received relating to a corporation tax return that had already been submitted. HMRC confirmed that this penalty has been removed.

## **3.Distribution to Shareholders**

A first distribution totalling £150,400 representing a dividend of £30.07 per £1 ordinary share was made to shareholders on 9 March 2020.

A final distribution will be paid shortly prior to closure of the Liquidation.

## **4. Liquidator's Remuneration, Disbursements and Expenses**

The members passed a resolution that the Liquidator's remuneration should be calculated on a fixed fee of £1,500 plus VAT. The amount of fees drawn to date is £1,500 exclusive of VAT.

The Liquidator's disbursements are a recharge of actual costs incurred by the Liquidator in dealing with this matter. Mileage payments made for expenses relating to the use of private vehicles for business travel, which is directly attributable to the insolvency estate, are paid by FRP Advisory Trading Limited at the HMRC approved mileage rate prevailing at the time the mileage was incurred. Details of disbursements incurred during the period of this report are set out in **Appendix B**.

I also attach at **Appendix C** a statement of expenses that have been incurred during the period covered by this report. It is currently expected that the expenses incurred or anticipated to be incurred are not likely to exceed the details provided prior to the determination of the basis of the Liquidator's remuneration.

When instructing third parties to provide specialist advice and services, or having the specialist services provided by the firm, the Liquidator is obligated to ensure that such advice or work is warranted and that the advice or work contracted reflects the best value and service for the work being undertaken. This is reviewed by the Liquidator periodically throughout the duration of the assignment. The specialists chosen may regularly be used by the Liquidator and usually have knowledge specific to the insolvency industry and, where relevant, to matters specific to this insolvency appointment.

Shareholders have a right to request further information from the Liquidator and further have a right to challenge the Liquidator's remuneration and other expenses, which are first disclosed in this report, under the Insolvency (England and Wales) Rules. (For ease of reference these are the expenses incurred in the reporting period as set out in **Appendix C** only).

Alternatively, a hard copy of the relevant guide will be sent to you on request.
