ORDINARY RESOLUTION

1. This authority shall expire (unless previously varied as to duration, revoked or renewed by the Company) on the date falling 5 years from the date of this Resolution, except that the Company may before such expiry make any offer or agreement which would or might require shares to be allotted or such rights to be granted after such expiry and the directors may allot shares or grant such rights in pursuance of such offer or agreement as if the authority conferred by this Resolution had not expired.

SPECIAL RESOLUTION

- 2. THAT the directors be generally empowered pursuant to section 570 of the Act to allot equity securities (as defined in section 560 of the Act) for cash pursuant to the general authority conferred on them by Resolution 1 as if any restrictions as to pre-emption, including but not limited to, the restrictions contained in section 561 of the Act, and any rights of pre-emption as set out in article 13 of the Company's existing articles of association, did not apply and be and are hereby waived. This authority shall expire, unless previously revoked or renewed by the Company, falling 5 years from the date of this Resolution except that the Company may before such expiry make any offer or agreement which would or might require equity securities to be allotted after such expiry and the directors may allot equity securities in pursuance of such an offer or agreement as if the power conferred by this Resolution had not expired.
- 3. **THAT** the articles of association in the form attached to this Resolution be adopted as the new articles of association of the Company in substitution for and to the exclusion of all existing articles of association of the Company (the "New Articles").
