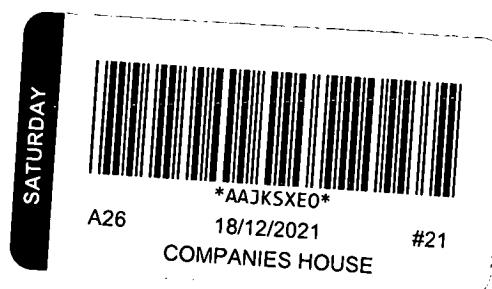

The directors present their report and the audited financial statements of the company for the year ended 31 March 2021.

**PRINCIPAL ACTIVITIES AND BUSINESS REVIEW**

The principal activity of the Company is the provision of accommodation-based services for adults with learning disabilities based in Cranbrook, Kent. These are provided for up to 24 people across two residential services regulated by the Care Quality Commission and one Supported Living accommodation. Maximum occupancy levels were reduced from 25 due to contract requirements within Supported Living settings.

The services moved to new contract rates in June 2020 following the KCC tender for all residential and supported living services.

The COVID-19 pandemic was well managed within the services with specific purchases made in relation to the management of the environments as a result of the Infection Control Funds received in locations and with support of the Friends of Benenden Grange charity.

Representation at the Independent Police Advisory Group as a Learning Disability representative continues but work on this project has been limited due to the pandemic, this is expected to pick up in 2021 / 2022

**FUTURE OUTLOOK**

It is the intention of the directors that the company will continue to create a profit. There are plans to increase the occupancy within the supported living service which will enable the business to return to supporting up to 25 people. The aim is to retain a minimum occupancy of 90% through continued positive working relationships with commissioners in the locality with further exploration of increasing Supported Living occupancy.

**PRINCIPAL RISKS AND UNCERTAINTIES**

Maintaining and increasing occupancy levels - Local authority preference is Supported Living Accommodation and therefore the referral pool to residential is limited. This is coupled with the need for futures referrals to be independently mobile due to the nature of the properties.

Recruitment and Retention - The sector continues to face challenges in relation to the recruitment and retention of staff. Within the company this is further challenged by services being placed within affluent and rural areas.

The impact of COVID-19 continues to have an effect on the services. The emotional and social well-being of individuals is a top priority to enable people to continue to maintain relationships with friends and family and regain their social independence at a time when it is safe to do so.

**RESULTS**

The operating profit for the year was £115K (2020: 100K). After donations of £77k to QEF, the parent company, the net effect on the balance sheet is an increase of £38k from £883k as at 31 March 2020 to £921k as at 31 March 2021.

**KEY PERFORMANCE INDICATORS ("KPIs")**

Operating Profit – During 2020/2021, the company achieved an operating profit of £115,000.

Contracts – 2019/2020 the company worked towards maintaining existing contracts through contract tender with Kent. The outcome of this has been achieved in the 2020/2021 financial operating year.

Quality – The Grange and 17 Wheatfield Drive have maintained their Good rating with the CQC with The Grange holding 1 outstanding domain. The Grange received an Infection Prevention and Control Inspection in 2021 and the CQC were assured by the services IPC measures.

Occupancy levels – a target of maintaining a minimum occupancy of 90% was met through part of the financial year but this reduced to 87.5% occupancy in October 2021. This is expected to increase within the second quarter of 2021 / 2022.

**GOING CONCERN**

The Directors consider that the Company is a going concern. COVID-19 has had an impact on the Company from a financial perspective as the usage and cost of PPE equipment has increased, however, the government has set aside funds to help care homes cover the additional costs and the Company has benefited from some of these funds. The effects of COVID-19 on the finances of The Grange are not significant and do not greatly impact on the going concern.

**1. ACCOUNTING POLICIES**

COMPANY INFORMATION

THE GRANGE (2016) LTD is a limited company, limited by shares, domiciled and incorporated in England and Wales. The registered office is The Grange, The Green, Benenden, Cranbrook, Kent, TN17 4DN

(a) ACCOUNTING CONVENTION

These financial statements for the year ended 31 March 2021 have been prepared in accordance with Section 1A of FRS 102, The Financial Reporting Standard applicable in the UK and Republic of Ireland.

The financial statements are prepared in sterling, which is the functional currency of the company. Monetary amounts in these financial statements are rounded to the nearest thousand pound.

The financial statements have been prepared on the historical cost convention. The principal accounting policies adopted are set out below.

(b) TURNOVER

Turnover comprises the fair value of the consideration received or receivable for the provision of services in the ordinary course of the company's activities. The company recognises revenue based upon the period in which the care service was delivered.

(c) GOVERNMENT GRANTS

Government grants are recognised at the fair value of the asset received or receivable when there is reasonable assurance that the grant conditions will be met and the grants will be received. A grant that specifies performance conditions is recognised in income when the performance conditions are met. Where a grant does not specify performance conditions, it is recognised in income when the proceeds are received or receivable. A grant received before the recognition criteria are satisfied is recognised as a liability.

(d) TANGIBLE FIXED ASSETS

Tangible fixed assets are initially measured at cost and subsequently measured at cost or valuation, net of depreciation and any impairment losses. All fixed assets, with a value over £1,500 are capitalised.

Depreciation is recognised so as to write off the cost or valuation of assets less their residual values over their useful lives on the following basis:

Fixtures, fittings and equipment	1 to 5 years on a straight line basis
Motor vehicles	2% per annum on a straight line basis
Land and Buildings	not depreciated

The gain or loss arising on the disposal of an asset is determined as the difference between the sale proceeds and the carrying value of the asset, is recognised in the profit and loss account.

#### **ACCOUNTING POLICIES (Cont'd)**

##### **(e) CASH AND CASH EQUIVALENTS**

Cash and cash equivalents include cash in hand and balances held at call with banks.

##### **(f) FINANCIAL INSTRUMENTS**

The company only has financial instruments classified as basic and measured at amortised cost. The company has no financial instruments that are classified as 'other' or financial instruments measured at fair value.

##### **(g) EQUITY INSTRUMENTS**

Equity instruments issued by the company are recorded at the proceeds received, net of direct issue costs. Dividends payable on equity instruments are recognised as liabilities once they are no longer at the discretion of the company.

##### **(h) TAXATION**

The tax expense represents the sum of the tax currently payable and deferred tax.

##### **CURRENT TAX**

The tax currently payable is based on taxable profit for the period. Taxable profit differs from net profit as reported in the profit and loss account because it excludes items of income or expense that are taxable or deductible in other periods and it further excludes items that are never taxable or deductible. The company's liability for current tax is calculated using tax rates that have been enacted or substantively enacted by the reporting end date.

##### **DEFERRED TAX**

Deferred tax liabilities are generally recognised for all timing differences and deferred tax assets are recognised to the extent that it is probable that they will be recovered against the reversal of deferred tax liabilities or other future taxable profits. Such assets and liabilities are not recognised if the timing difference arises from goodwill or from the initial recognition of other assets and liabilities in a transaction that affects neither the tax profit nor the accounting profit.

The carrying amount of deferred tax assets is reviewed at each reporting end date and reduced to the extent that it is no longer probable that sufficient taxable profits will be available to allow all or part of the asset to be recovered. Deferred tax is calculated at the tax rates that are expected to apply in the period when the liability is settled or the asset is realised. Deferred tax is charged or credited in the profit or loss account, except when it relates to items charged or credited directly to equity, in which case the deferred tax is also dealt with in equity. Deferred tax assets and liabilities are offset when the company has a legally enforceable right to offset current tax assets and liabilities and the deferred tax assets and liabilities relate to taxes levied by the same tax authority.

**(i) PROVISIONS**

Provisions are recognised when the company has a legal or constructive present obligation as a result of a past event, it is probable that the company will be required to settle that obligation and a reliable estimate can be made of the amount of the obligation.

The amount recognised as a provision is the best estimate of the consideration required to settle the present obligation at the reporting end date, taking into account the risks and uncertainties surrounding the obligation.

Where the effect of the time value of money is material, the amount expected to be required to settle the obligation is recognised at present value. When a provision is measured at present value the unwinding of the discount is recognised as a finance cost in profit or loss in the period it arises.

**(j) EMPLOYEE BENEFITS**

The costs of short-term employee benefits are recognised as a liability and an expense, unless those costs are required to be recognised as part of the cost of stock or fixed assets.

The cost of any unused holiday entitlement is recognised in the period in which the employee's services are received.

Termination benefits are recognised immediately as an expense when the company is demonstrably committed to terminate the employment of an employee or to provide termination benefits.

**(k) RETIREMENT BENEFITS**

A defined contribution plan is a pension plan under which fixed contributions are paid into a pension fund and the company has no legal or constructive obligation to pay any further contributions even if the fund does not hold sufficient assets to pay all employees the benefits relating to employee service in the current and prior periods.

Contributions to defined contribution plans are recognised as employee benefit expense when they are due. If contribution payments exceed the contribution due for service, the excess is recognised as a prepayment.

**(l) LEASES**

Rentals payable under operating leases, including any lease incentives received, are charged to expenditure on a straight line basis over the term of the relevant lease.

#### (m) GOING CONCERN

The directors have assessed whether the use of the going concern basis is appropriate and have considered possible events or conditions that might cast significant doubt on the ability of the company to continue as a going concern. The directors have made this assessment for a period of at least one year from the date of the approval of these financial statements. In particular the directors have considered the company's forecasts and projections. The directors recognise that COVID-19 continues to pose unique challenges, and will continue to utilise all government support available. Procedures to maintain social distancing and enhance cleaning have continued to be used to minimise risk. After making enquiries, the directors have concluded that there is a reasonable expectation that the company has adequate resources to continue in operational existence for the foreseeable future. The company therefore continues to adopt the going concern basis in preparing its financial statements.
