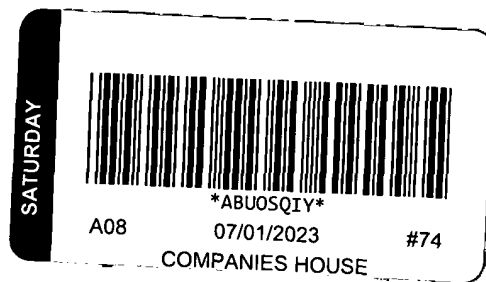

**1 Statutory information**

DAVID TETT PHOTOGRAPHY LTD. is a private company, limited by shares, registered in England and Wales, registration number 10208320. The registered office is 84 EWHURST ROAD, LONDON, SE4 1SD, ENGLAND.

**2 Average number of employees**

During the year the average number of employees was 1 (2020: 1).
