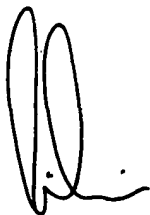
STRATEGIC REPORT

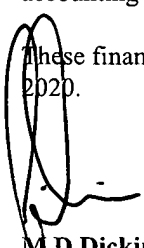
