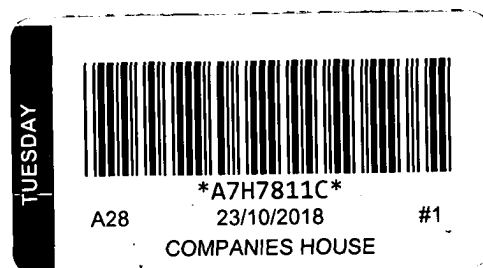

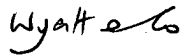

During the year, the company provided a loan to one director. The opening balance was £7,839, the closing and highest balance was £346. The loan was interest free and repayable on demand.

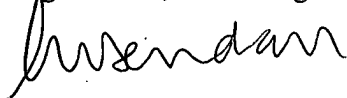
For the year ending 31 March 2018 the company was entitled to exemption from audit under section 477 of the Companies Act 2006 relating to small companies.
