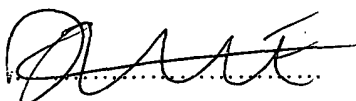
For the period from 01 August 2021 to 31 July 2022 the Company was entitled to exemption under section 480 of the Companies Act 2006.
