Arterne: Enriching the next generation CIC has focused on the following areas of work;

- Children, Young People and their families and/or;
- Other professionals working with Children, Young People and their families

Assessment, individual, family and group work has been offered by Arterne CIC utilising a number of approaches and models of practice. Aiming to address behavioural concerns and mental health promotion, this work has focused on improving communication, relationships and intergenerational patterns of behaviour within families and communities.

This work has included the development of 'SEA-ing Changes' as an activity-based group work programme for families which takes place on the beach (delivered in partnership) and Platform 50 as a women's coaching and mentoring project delivered through the support of volunteers which required review due to the pandemic.

- Adults identified as being in vulnerable groups and/or;

- Across all ages support for people in the community and within businesses

Arterne CIC has worked with individuals, families and professionals from a variety of communities and organisations to help to improve mental and physical health. This has included assessment, risk assessment and follow up, support during employment, individual work using several approaches and models, group work and bespoke training. Operation Snow #notjustforchristmas has provided community with non-perishable items and worked with local businesses to offer hot nutritional food. We were unable to deliver our usual Christmas period support due to the pandemic and restrictions so found different ways to support people. This support was crucial throughout the pandemic and was largely run by volunteers. Platform 50 is aimed at women aged 16-25 and is supported by a group of volunteers who are coordinated by Arterne CIC to undertake coaching and mentoring. During the pandemic we altered the age range as we found more women in need of support outside of the specified age range also. The Op Shop provides second hand items at a reduced cost and a place to go as a community hub when help is needed. Arterne CIC has also successfully linked to support people who have presented at hospital and then once assessed been redirected to access support from Arterne CIC. There has been significant work with schools as they also were challenged to support families throughout the pandemic. Coronavirus required everyone to develop structures and business models and this year has been challenging for many people because of this- we were in a position where we needed to furlough employees. We have also relooked at income streams and applied for more grants to support our work. Some of these were successful and enabled us to adapt to offer support needed.

Professionals from a variety of organisational structures and types

Arterne CIC has been working within organisations who have been assessed as inadequate by the Care Quality Commission whilst providing Health and Social Care. This has required the provision of consultancy and leadership. Arterne CIC has also supported other Charities and Community Interest Companies to support local communities. This has been in the form

of supervision to help professionals serve the local population. Support for organisations to interpret legislation and evidence- b as ed research has helped to guide them to safeguard the people they work with and ensure that they receive quality care. This has required whole system development. We have also placed some workers within other businesses as help was needed due to recruitment/retention/shortages within health and social care. We felt partnership was key and our work overlapped so it was possible to make this transition during the pandemic so that people could receive the support they needed.

Arterne CIC has provided support for across all age ranges through partnership work with other agencies and employing professionals with the right knowledge, skill and experience to meet the needs of individuals, families, professionals and communities at the right time. This has been through therapeutic intervention, music, exercise, activity-based programmes of work/support. Holistic assessment has been an important aspect of this work and working across health and social needs to address problems/concerns. Operation Snow and Operation Snow #not just for Christmas has enabled a place for everyone to spend time together, eat well and in the warm, on Christmas Day (although during the pandemic this was not possible due to restrictions).

The Director has written a book- all monies from book sales go to Arterne CIC as an additional income stream for the CIC. This book supports the CIC which is based on the model of L.O.V.E Leadership which is detailed within the book. It is available on Amazon and Waterstones. The Director was listed in the UK top 10 for the Nursing Times Florence Nightingale Nurse of the Year Award 2020 alongside many other prestigious nurses which was a significant achievement particularly during the challenges of the pandemic.

Consultation is a key element of ensuring that Arterne CIC delivers the support it is commissioned to do. Bespoke training to improve employee knowledge such as mental health, drugs and alcohol misuse, safeguarding, changing whole systems to improve patient/client care relies on consultation with key audiences. We also support loss/grief and offer bereavement work for all ages. Arterne CIC has consulted with leadership teams to help support company employees through training as well as receiving feedback from those attending, which helps shape future training. Participation with services users is invited for each activity Arterne CIC is involved with to try an assist with improving service user experience. An example of this is how residents in a residential care home wanted their home shaped which resulted in Arterne CIC supported the care homeowner to address. You can see the improvements detailed within Care Quality Commission inspection reports and training/group evaluation. We have also been directly commissioned by the Local Authority to provide support to care homes affected by leadership/cultural issues and Coronavirus.
