

  - 4.1.2 a company or other entity to whom such shares are transferred at the direction of a Financial Institution and/or any administrative receiver, administrator, receiver or receiver and manager or similar entity (a Receiver) pursuant to powers granted to it under the Security; and
- 4.2 is delivered to the Company for registration in order to perfect or protect any Security of a Financial Institution; or
- 4.3 is executed by a Financial Institution or Receiver pursuant to a power of sale or other such power under any Security.
