For the period ended 31 August 2019, the company was engaged in a health and wellness project. The objectives of the project were:

- Promote health nutrition and well-being activities that intrinsically advances lives through a series of practical and theory programme activities. That In return this will improve community cohesion and economic well-being.
- Over the course of Six Months we will deliver a series of 1 hours of health nutrition and wellbeing activities weekly
- Over the course of Six Months we will deliver a series of 1 hours of health nutrition and wellbeing activities weekly, to a group of 24 young persons/adults between the ages of 18 - 29.
- By the end of the programme the young person/adult will be very clear on the importance of sports nutrition and why it is key to obtaining fitness and performance. By the end of the programme the young person/adult will be very clear on the importance of compound exercise and why it is key to obtaining fitness and overcoming depression.

Over the course of the six months we provided weekly (What we are now calling) an hour of 'Nonclinical Healthy Living Classes', to a total of 24 participants. Which in return created a non-judgmental, positive engaging experience tailored to the individuals needs and strengths.

The benefits and outcomes as a result of MyVoice Neighbourhood Improvement Grant Funding by Wandle saw young people being able to manage their own health and well-being, be very clear on the importance of nutrition, increased healthier choices, increased knowledge of healthy foods, food skills and improved eating habits; advanced physical, spiritual, mental and emotional health, healthy eating, well-being and safety; feel part of a community; understand the necessity of incorporating more social engagement activities into their daily lives and routines and why it is key to obtaining fitness and overcoming loneliness, including stress, depression and anxiety.

With high ambitions and a very tight timeframe, we worked for an intensive 3-week period to develop an inclusive engagement approach, designed to ensure we reached a wide range of participants of Wandle residents; this approach proved successful, leading to an increase of Wandle tenants taking part in the project, and us exceeding our projected target.

This also led to us having to set-up a database with a waiting list of potential clients wanting to participate in future projects of this kind.
