

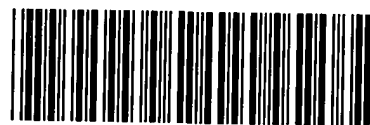

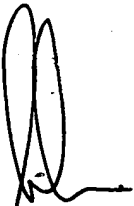
STRATEGIC REPORT

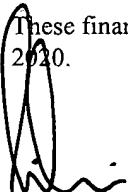
