THIS DEED OF ASSIGNMENT is dated 5 October 2023

BETWEEN:

- (1) BRIDGES PROPERTY ALTERNATIVES FEEDER FUND VI LP (registered in England and Wales as a limited partnership under the Limited Partnerships Act 1907 with number LP023227) (acting through its manager, BRIDGES FUND MANAGEMENT LIMITED) (the "Feeder");
- (2) BRIDGES FUND MANAGEMENT LIMITED (incorporated in England and Wales with registered number 10401079) (the "Manager");
- (3) BRIDGES PROPERTY ALTERNATIVES FUND VI (GENERAL PARTNER) LLP (incorporated in England and Wales with registered number OC447096) (the "General Partner"); and
- (4) THE ROYAL BANK OF SCOTLAND INTERNATIONAL LIMITED, LONDON BRANCH as security trustee for the Secured Parties (the "Security Agent").

RECITALS:

- (A) By a facility agreement (the "Facility Agreement") dated on or around the date of this Deed, and made between, among others, Bridges Property Alternatives Fund VI LP (the "Borrower") and the Security Agent, each Lender agreed to make available to the Borrower a revolving credit facility.
- (B) Each Assignor enters into this Deed and grants the security hereby constituted in favour of the Security Agent (on behalf of the Secured Parties) to secure the repayment and satisfaction of the Secured Liabilities.

IT IS AGREED as follows:

1. DEFINITIONS AND INTERPRETATION

1.1 In this Deed:

- "Assigned Rights" means, in relation to an Assignor, all of its rights, title and interest under the Partnership Documents:
- (a) to and in respect of the Commitments (including the Undrawn Commitments), including to the proceeds thereof;
- (b) to and in respect of Re-investment Cash, including to the proceeds thereof;
- (c) to and in respect of, and to require Investors to return to the Feeder, any amounts distributed by the Feeder to the Investors;
- (d) to execute and deliver Drawdown Notices and to receive and apply the proceeds thereof; and
- (e) to otherwise require, and enforce the obligations of the Investors to contribute or advance, the Commitments (including the Undrawn Commitments);
- "Assignors" means, together, the Manager, the General Partner and the Feeder, and each is an "Assignor";
- "Commitment" has the meaning ascribed to that term in the Limited Partnership Agreement;

- "Drawdown Notice" has the meaning ascribed to that term in the Limited Partnership Agreement;
- "Enforcement Event" means the service of a notice by the Agent in accordance with clause 25.29 (Acceleration) of the Facility Agreement;
- "Investor" has the meaning ascribed to that term in the Limited Partnership Agreement;
- "Limited Partnership Agreement" means the amended and restated limited partnership agreement dated 24 March 2021 governing the Feeder.

"Partnership Documents" means:

- (a) the Limited Partnership Agreement;
- (b) the management agreement dated 24 March 2021 between the General Partner and the Manager; and
- (c) any Application Form and any Side Letter (each as defined in the Limited Partnership Agreement);
- "Re-investment Cash" has the meaning ascribed to that term in the Limited Partnership Agreement;
- "Secured Liabilities" means all present and future liabilities and obligations at any time due, owing or incurred by any Transaction Obligor to any Secured Party under the Finance Documents, both actual and contingent and whether incurred solely or jointly and as principal or surety or in any other capacity;
- "Security Period" means the period beginning on the date of this Deed and ending on the date that the Security Agent is satisfied that the Secured Liabilities have been irrevocably and unconditionally satisfied in full; and
- "Undrawn Commitment" has the meaning ascribed to that term in the Limited Partnership Agreement.
- 1.2 In this Deed, unless a contrary intention appears:
 - 1.2.1 capitalised terms used herein shall have the meaning ascribed to them in the Facility Agreement;
 - 1.2.2 references to "clauses" and the "schedule" are references to, respectively, clauses of and the schedule to this Deed and references to this Deed include its schedule;
 - 1.2.3 a time of day is a reference to London time;
 - 1.2.4 the contents page of and the headings in this Deed are inserted for convenience only and are to be ignored in construing this Deed;
 - 1.2.5 words importing the plural shall include the singular and vice versa;
 - 1.2.6 unless expressly provided to the contrary in this Deed, a person who is not a party to this Deed may not enforce any of its terms under the Contracts (Rights of Third Parties) Act 1999; and
 - 1.2.7 notwithstanding any term of this Deed, the consent of any third party is not required for any variation (including any release or compromise of any liability under) or termination of this Deed.

1.3 It is intended that this document shall take effect as and be a deed of each Assignor notwithstanding the fact that the Security Agent may not execute this document as a deed.

2. ASSIGNMENT

As continuing security for the payment of the Secured Liabilities each Assignor as beneficial owner hereby assigns absolutely by way of security with full title guarantee to the Security Agent (on behalf of the Secured Parties) all of its Assigned Rights.

3. RESTRICTIONS

- 3.1 No Assignor shall, save as otherwise permitted under the Facility Agreement, without the prior consent in writing of the Security Agent:
 - 3.1.1 save for the Transaction Security, create or permit to exist any Security over the Assigned Rights;
 - 3.1.2 amend, terminate or vary, or agree any amendment or termination of, or variation in, (unless such amendment, variation or termination would not or might not impair the title, interests or rights of the Security Agent to and in the Assigned Rights) any Partnership Document;
 - 3.1.3 sell or otherwise dispose of or agree to sell or otherwise dispose of its benefit in the Assigned Rights; or
 - 3.1.4 take or omit to take any action the taking or omission whereof would or might impair the title, interests or rights of the Security Agent to and in the Assigned Rights,

save that nothing in this clause 3 shall prevent an Assignor exercising its Assigned Rights (including the service and enforcement of Drawdown Notices on the Investors in relation to their respective Commitments in accordance with the provisions of the Partnership Documents) to the extent permitted under the Finance Documents.

4. POWERS OF THE SECURITY AGENT

- 4.1 Upon the occurrence of Enforcement Event, the Security constituted by this Deed shall become immediately enforceable.
- 4.2 The Security Agent may at any time following the occurrence of an Enforcement Event without further notice and without the restrictions contained in section 103 of the Law of Property Act 1925 exercise in respect of the Assigned Rights all the powers conferred on mortgagees by the Law of Property Act 1925 as hereby varied or extended with full power to call in all or any moneys forming part of the Assigned Rights and to enforce all rights to receive moneys forming part of the Assigned Rights in each case under the terms of this Deed and in all cases subject to compliance with the terms of this Deed.
- 4.3 The Security Agent may apply all moneys it receives in respect of Assigned Rights relating to any Assignor in or towards discharge of the Secured Liabilities in such order as the Security Agent in its absolute discretion may from time to time determine.

5. ATTORNEY

5.1 Each Assignor, by way of security, irrevocably appoints the Security Agent and any person nominated for the purpose by the Security Agent (in writing and signed by an officer of the

Security Agent) as its attorney (with full power of substitution and delegation) in its name and on its behalf and as its attorney following the occurrence of an Enforcement Event:

- 5.1.1 to execute or deliver Drawdown Notices to any Investor to the extent necessary to ensure that each Assignor shall pay each amount due by the same under the Finance Documents on the due date for payment therefor, and
- 5.1.2 to execute and deliver and otherwise perfect and do, any deed, assurance, agreements, instrument, act or thing which it ought to execute and do under the terms of this Deed, or which may be required or deemed proper in the exercise of any rights or powers conferred on the Security Agent under this Deed or otherwise for any of the purposes of this Deed.
- 5.2 Each Assignor covenants with the Security Agent to ratify and confirm all such acts or things made, done or executed lawfully by that attorney in accordance with the terms of this Deed.

6. UNDERTAKINGS

The Assignors shall promptly following the date of this Deed, and in respect of any entity or person that becomes an Investor following the date of this Deed, promptly upon becoming an Investor, send to each Investor a notice of assignment in the form set out in the schedule (Form of notice to Investors) and shall use reasonable endeavours to procure that each Investor promptly delivers a copy of such notice duly acknowledged to the Feeder and the Security Agent.

7. WARRANTIES

Each Assignor hereby represents and warrants to the Security Agent that:

- 7.1.1 subject to the Legal Reservations, the Security constituted by this Deed constitutes first ranking Security over its Assigned Rights; and
- 7.1.2 save for the Security created by this Deed, it has not assigned, charged, pledged or otherwise created Security over its Assigned Rights.

8. OTHER SECURITY

- 8.1 The Security created by this Deed is in addition to, and shall neither be merged in, nor in any way exclude or prejudice, any other Security, right of recourse or other right whatsoever which the Security Agent may now or at any time hereafter hold or have (or would apart from this Security hold or have) as regards the Assignor or any other person in respect of the Secured Liabilities.
- 8.2 The powers which this Deed confers on the Security Agent are cumulative, without prejudice to its powers under the general law and may be exercised as often as the Security Agent thinks appropriate. The Security Agent may, in connection with the exercise of its powers, join or concur with any person in any transaction, scheme or arrangement whatsoever and each Assignor acknowledges that the powers of the Security Agent shall in no circumstances whatsoever be suspended, waived or otherwise prejudiced by anything other than an express waiver or variation in writing.

9. PROTECTION OF SECURITY AGENT

The Security Agent shall not be liable in respect of any loss or damage which arises out of the exercise, or the attempted or purported exercise of or the failure to exercise any of its powers, unless such loss or damage is caused by its gross negligence or wilful default.

10. ANCILLARY PROVISIONS

- 10.1 The Security constituted by this Deed shall be and remain a continuing security for the payment of the Secured Liabilities and shall apply notwithstanding any fluctuation in or the intermediate payment of any part or full satisfaction of the Secured Liabilities and notwithstanding any change in the constitution of any Assignor or the invalidity or enforceability of this Deed in respect of any Assignor and the charges, covenants and provisions contained in this Deed.
- Each Assignor shall be deemed to be a principal debtor, and the sole, original and independent obligor for the Secured Liabilities owed by it and its Assigned Rights shall be deemed to be a principal security for the Secured Liabilities owed by it and the liability of each Assignor under this Deed and the assignments contained in this Deed shall not be impaired by any forbearance, neglect, indulgence, extension of time, release, surrender or loss of securities, dealing, variation or arrangement by the Security Agent, or by any other act, event or matter whatsoever whereby the liability of any Assignor (as a surety only) or the charges contained in this Deed (as secondary or collateral charges only) would, but for this provision, have been discharged.

11. RELEASE

Upon the expiry of the Security Period (but not otherwise) the Security Agent shall, at the request and cost of the Assignors, take any action reasonably necessary to re-assign an Assignor's Assigned Rights to such Assignor.

12. MISCELLANEOUS

- 12.1 If any provision of this Deed is or becomes invalid, illegal or unenforceable in any respect under any law (in a particular jurisdiction), the validity, legality and enforceability of the remaining provisions in that jurisdiction or the validity, legality and enforceability of any provision of this Deed in any other jurisdiction shall not in any way be affected or impaired.
- 12.2 No failure to exercise and no delay in exercising on the part of the Security Agent any right, remedy, power or privilege arising under or by virtue of this Deed shall operate as a waiver thereof nor shall any single defective or partial exercise thereof preclude any other or further exercise of that or any other right, remedy, power or privilege and the rights and remedies provided in this Deed are cumulative and not exclusive of any other rights or remedies provided by law.
- 12.3 The contents of any certificate signed by any officer of the Security Agent as to the amount of the Secured Liabilities or as to any determination made by the Security Agent under or for the purposes of this Deed shall (in the absence of manifest error) as against each Assignor be conclusive evidence of that matter in any legal proceedings.
- 12.4 Each Assignor agrees at the cost and expense of such party to execute and deliver such further documents and do such other acts and things as the Security Agent may reasonably request in order further to effect the purposes of this Deed and the due performance by each Assignor of its obligations hereunder.

- 12.5 Each Assignor acknowledges that this Deed does not contravene any of the provisions of the Partnership Documents or of any other agreement or document binding on any party hereto (where such contravention has, or is reasonably likely to have, a Material Adverse Effect) and has been executed in accordance with the Limited Partnership Agreement.
- 12.6 Any notice or demand under this Deed to or upon an Assignor shall be in writing and shall be deemed to have been properly served upon such Assignor if it is served in accordance with clause 34 (*Notices*) of the Facility Agreement.

13. COUNTERPARTS

This Deed may be executed in any number of counterparts, and this has the same effect as if the signatures on the counterparts were on a single copy hereof.

14. GOVERNING LAW

This Deed and any non-contractual obligations arising out of or in connection with it are governed by English law.

15. ENFORCEMENT

Jurisdiction of English courts

- 15.1 The courts of England have exclusive jurisdiction to settle any dispute arising out of or in connection with this Deed (including a dispute relating to the existence, validity or termination of this Deed or any non-contractual obligation arising out of or in connection with this Deed) (a Dispute).
- 15.2 The Parties agree that the courts of England are the most appropriate and convenient courts to settle Disputes and accordingly no Party will argue to the contrary.
- This clause 15 is for the benefit of the Security Agent. As a result, the Security Agent shall not be prevented from taking proceedings relating to a Dispute in any other courts with jurisdiction. To the extent allowed by law, the Security Agent may take concurrent proceedings in any number of jurisdictions.

This Deed has been entered into and delivered as a deed on the date stated at the beginning of this Deed.

We further notify you that:

- 1. you may continue to deal with the Partnership, the General Partner and the Manager in relation to the Partnership Documents unless and until you receive written notice to the contrary from the Security Agent. Thereafter the Partnership, the General Partner and the Manager will cease to have any of such rights to deal with you in respect of the Rights and therefore from that time you should deal only with the Security Agent in respect of the Rights;
- 2. you are authorised to disclose information in relation to the Rights to the Security Agent on request;
- 3. after receipt of notice in accordance with paragraph 1 above, you must pay all monies to which the Partnership, the General Partner or the Manager are entitled under the Partnership Documents in respect of the Rights direct to the Security Agent (and not to the Partnership, the General Partner or the Manager) unless the Security Agent otherwise agrees in writing; and
- 4. the provisions of this notice may only be revoked with the written consent of the Security Agent.

Please sign and return the enclosed copy of this notice to the Security Agent (with a copy to the Manager) by way of confirmation that:

- (a) you agree to the terms set out in this notice and to act in accordance with its provisions;
- (b) you have not received notice that the Partnership, the General Partner or the Manager has assigned its Rights under the Partnership Documents to a third party or created any
