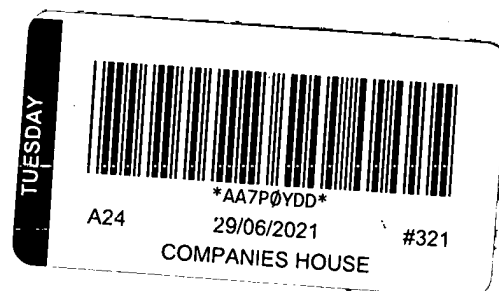

The members have not required the company to obtain an audit of its financial statements for the year in question in accordance with section 476.



Lisvane Panthers FC was formed in 1989 as a community football club to support local youngsters from the Lisvane area of Cardiff. As we complete our 31st season, we remain one of the largest junior football clubs in Wales, providing football for many youngsters living in North Cardiff.

This season, we fielded 38 teams, involving 550 registered players (from 6-year-olds to adults) who have been supported by more than 150 adult volunteers. Our teams played at mini, junior and adult levels in the Cardiff & District Association Football League. All teams benefitted from great support from the touchlines – from siblings, parents and grandparents – numbering over 1,000.

The club remains popular and continues to attract youngsters from all over North Cardiff. We endeavour to play positive, attractive football and promote fair play and respect for officials and opponents. We continue to offer playing opportunities and deliver structured training sessions by qualified coaches. This is supported by a robust Coach Education Program, through links to the Welsh Football Trust, with whom we've worked closely to retain the status of a FAW-Accredited Club.

The benefits to the children's health and wellbeing are unquestionable, but they have also learned important life skills, too. Co-operation, teamwork, self-discipline and the realisation that application brings rewards in both their performance and enjoyment, are all key components of their development. As well as improving physical fitness and building confidence and self-esteem, our youngsters have demonstrated that they have developed a camaraderie, not just with their club teammates, but with footballers from all over Cardiff, who share their passion for the game.

Unfortunately, the Covid-19 pandemic severely impacted the end of our season. League fixtures and cup competitions were cancelled as a national lockdown was introduced. Training was cancelled and all football stopped. However, the players had enjoyed the early part of the season and looked forward to when they could, once again, don the tangerine and black club colours and take to the parks of Cardiff.

The club holds monthly meetings where adult volunteers share feedback with the committee and develop club policy. Players' parents are welcome to attend.

The CIC Board is comprised of 7 Directors, each with many years' experience of and service to the club. The club committee is comprised of 15 volunteers who support the day-to-day operation of the football club. The CIC Board liaises closely with the club committee and offers support, guidance, and governance.

Also, we have club representatives who attend regular meetings with the Court Field Committee, in Llanishen, and the Lisvane Community Association and Lisvane Community Council. This provides an opportunity for local residents and community leaders to engage, directly, with club officials.

Unfortunately, the restrictions introduced to tackle the Covid-19 pandemic meant that we were unable to hold our three, annual, end-of-season Presentation events. We have always used these events as an opportunity to celebrate our players' achievements and to demonstrate that the club is very much part of the community. So, it was unfortunate that we could not continue this well-loved tradition, this year. However, our team managers kept in close contact with their players and their parents, throughout these difficult times, so the link to the community was always maintained.
