The Human Flourishing Project saves lives. In the last year we are convinced that providing access to counselling through the HFP we have ensured that some members of the community in Nottingham were prevented from making an attempt on their life. We know this because we have partnered with the local statutory services, who have made referrals to the HFP and have continued to work with clients alongside the work that we have done. Being able to fund a project that meets people in a way that provides support in times of difficulty is a wonderful thing to do and those students that are part of this are permanently changed by this experience.

Working on a placement in the HFP brings an exceptional enhancement to the student experience. The project offers students the chance to join the organisation, which is listed as a Cooperative Community Interest Company, and become fully engaged in the running of the organisation and participate at every level of its operations. Each year, tasks and responsibilities are delegated to individuals or small groups of students who then take on responsibility for managing this aspect of the organisation. Students on placement have the opportunity for working in collaboration with other students in a team, with staff as colleagues in the HFP and with professionals from other agencies and organisations. The opportunities are highly valued by those students that have already participated in the project previously.

The work at the HFP is challenging for students. They are already in training to be counsellors and psychotherapists and this requires investment from them, emotionally, financially and dedication to their practice. They engage in their own personal counselling and this challenges them to reflect and evaluate on their life and how they became the person they are. This is part of the preparation for working with people that are distressed or confused or dissatisfied with their life. This work is demanding both emotionally and psychologically but it never leaves you and the rewards are huge. Students that have already been on placement have commented that they feel they are part of a magnificent project and that the HFP is doing something quite extraordinary for people in Nottingham. It has been live changing and life affirming for them to know they are able to make significant changes to their own life and personality whilst also knowing this makes a difference to the local community. They feel proud to do so under the umbrella of the HFP and the University of Nottingham.

The people that are helped by the HFP are also able to make lasting changes to their life. Because of the nature of this work we know that this has saved some people's lives and we know the benefit this has had on them, their families and the local communities in which people live. The people that use the HFP come from all parts of the city but often these are people from Aspley, Bulwell, St Anne's and other areas where there are families with low socio-economic status, that might be out of work or experiencing poor health. We have engaged well with people from BME backgrounds, older adults and other marginalised or stigmatised groups. We have now increased this service, and we now provide up to 6000 therapy hours per year.

The HFP project has engaged with professionals within the NHS locally. GPs and other specialist services have seen the benefits of the counselling service that HFP can provide and are now signposting their patients towards the HFP for help and support that they themselves are unable to provide.

The HFP is making a mark in Nottingham and on the students that undertake their placements there. These experiences are carried forward and on to many parts of the world where what is learned can be remembered and applied in new and challenging contexts.


