THAT, subject to the passing of resolution 1, the directors of the Company be generally empowered to allot equity securities (as defined in section 560 of the Act) pursuant to the authority conferred by resolution 1, as if the provisions of Article 12 of the Company's articles of association (or any other applicable pre-emption rights) did not apply to any such allotment, provided that this power shall i) be limited to the allotment of equity securities up to the aggregate nominal value described in resolution 1 and ii) expire on the fifth anniversary of the Circulation Date (unless renewed, varied or revoked by the Company prior to or on that date), save that the Company may, before such expiry make an offer or agreement which would or might require equity securities to be allotted after such expiry and the directors of the Company may allot equity securities in pursuance of any such offer or agreement notwithstanding that the power conferred by this resolution has expired.
