Special Resolutions

2. THAT, subject to the passing of resolution 1 and in accordance with section 570 of the Act, the directors be generally empowered to allot equity securities (as defined in section 560 of the Act) pursuant to the authority conferred by resolution 1, as if section 561(1) of the Act and article 3.2 of the Company's articles of association did not apply to any such allotment, provided that this power shall expire on date which is 1 year
