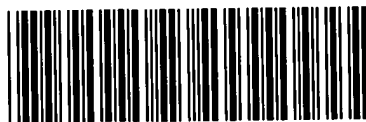

**Director's Responsibilities:**


The members have not required the company to obtain an audit of its accounts for the year in question in accordance with Section 476.
