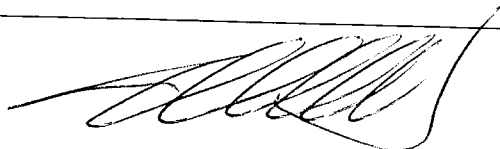

ORDER

UPON READING the application notice dated 8th December 2022

AND UPON the Court being satisfied that the application can be dealt with without the need for a hearing pursuant to Civil Procedure Rule 23.8(c)

AND UPON READING the evidence

IT IS ORDERED THAT:

1. Where required, the proceedings herein to be transferred to the High Court for the purpose of making the order sought and thereafter to be transferred back to the respective County Court.
2. Craig Andrew Ridgley (**First Outgoing Officeholder**) and Mark Grahame Tailby (**Second Outgoing Officeholders**) (together, the **Outgoing Officeholders**) be removed from office in respect of each of the cases in Parts 1 to 4 of the schedule (**Schedule**) attached to this order (**Block Transfer Cases**),
3. Ian Lawrence Goodhew (**Replacement Officeholder**) be appointed in place of the First Outgoing Officeholder in respect of each of the cases listed in Parts 1 and 2 of the Schedule, and in place of the Second Outgoing Officeholder in respect of each of the cases listed in Part 4

4. Abigail Shearing (**Replacement Officeholder**) be appointed in place of the Second Outgoing Officeholder in respect of each of the cases listed in Part 2 and in place of the First Outgoing Officeholder in respect of the case listed in Part 3 of the Schedule.
5. The Outgoing Officeholders shall receive their release as officeholders 28 days after the giving of notice to creditors (and, in the case of members' voluntary liquidations, the members) in accordance with this order, save that such release may be subject to further order in the event of an application by any creditor under paragraph 10 of this order for the specific case subject to that application.
6. The Replacement Officeholders shall notify the creditors or members (as applicable) in each of the Block Transfer Cases of this order by advertisement in the London Gazette (**Notice**) within 28 days of the sealed order being made available, stating:
 - 6.1. that the Outgoing Officeholders have been removed from office and that they have been replaced by the Replacement Officeholders as applicable;
 - 6.2. that the creditors or members (as applicable) have liberty to issue any application on notice within 28 days after the publication date of the Notice to vary or discharge the terms of this order; and
 - 6.3. the Outgoing Officeholders shall receive their release as officeholder 28 days after the publication date of the Notice.
7. The Replacement Officeholders shall give notice to the Secretary of State in respect of the insolvency proceedings listed in the Schedule of the terms of this order as soon as reasonably practicable.
8. In the event that the next report due in each matter listed in the Schedule is due within 28 days of the making of this Order, an extension of a further 56 days after the due date shall be permitted for the drafting and circulation to creditors of such report.
9. Save for any extension of time granted by paragraph 8 of this order, the removal and appointments granted by this Order shall not disturb the existing reporting cycle for each of the respective insolvency appointments listed in the Schedule and the current time limit for reporting to creditors on each of the cases shall continue irrespective of the removal and appointments made by this Order.
10. Any creditor or member (as applicable) in respect of any of the estates listed in the Schedule who has an objection to this order shall have 28 days from the publication date of the Notice to apply to court to set aside or vary the terms of this order. Such application shall not affect the transfer of the bulk transfer cases listed in the Schedule until further or other order by the court.
11. In relation to the insolvency proceedings listed in the Schedule and insofar as the Insolvency Act 1986 or the Insolvency (England and Wales) Rules 2016 (the **Rules**) contain any requirement for advertisement, the requirement shall be dispensed with (subject to further order of the Court). Insofar as the Outgoing Officeholders are required by law to give any notice of the removal from office, the Replacement Officeholders are entitled to sign and send any such notice on their behalf.
12. The requirements of Rule 12.38(3) of the Rules, that the Outgoing Officeholders shall file a copy of this order with each of the courts having jurisdiction over the cases listed in the Schedule, are disapplied save for administration proceedings.
13. There be no order as to costs.
